CAJ's submission to the Northern Ireland Ambulance Service's consultation on its draft Equality Scheme

March 2011



What is the CAJ?

The Committee on the Administration of Justice (CAJ) was established in 1981 and is an independent non-governmental organisation affiliated to the International Federation of Human Rights. CAJ takes no position on the constitutional status of Northern Ireland and is firmly opposed to the use of violence for political ends. Its membership is drawn from across the community.

The Committee seeks to ensure the highest standards in the administration of justice in Northern Ireland by ensuring that the government complies with its responsibilities in international human rights law. The CAJ works closely with other domestic and international human rights groups and makes regular submissions to a number of United Nations and European bodies established to protect human rights.

CAJ's activities include - publishing reports, conducting research, holding conferences, campaigning locally and internationally, individual casework and providing legal advice. Its areas of work are extensive and include policing, emergency laws and the criminal justice system, equality and advocacy for a Bill of Rights.

CAJ however would not be in a position to do any of this work, without the financial help of its funders, individual donors and charitable trusts (since CAJ does not take government funding). <u>Submission to the Northern Ireland Ambulance Service's</u> Consultation on its draft Equality Scheme

The Committee on the Administration of Justice ('CAJ') is an independent human rights organisation with cross community membership in Northern Ireland and beyond. It was established in 1981 and lobbies and campaigns on a broad range of human rights issues. CAJ seeks to secure the highest standards in the administration of justice in Northern Ireland by ensuring that the government complies with its obligations in international human rights law. CAJ is co-convener of the Equality Coalition. We welcome the opportunity to comment on Northern Ireland Ambulance Service's ('NIAS') consultation on its new equality scheme.

CAJ acknowledges NIAS's efforts in producing a comnprehensive equality scheme in good time to allow for Equality Commission ('ECNI') approval before the 1 May 2011 deadline. We are encouraged to see that NIAS has, on the whole, adopted the ECNI model scheme and considered its best application to the specific NIAS context. In particular, we welcome the addition of a commitment to audit existing information systems within one year (para 4.29). In this brief submission, we would like to query a few deviations from the ECNI model scheme and also suggest a few additions, which would strengthen the NIAS equality scheme.

We have noted a few small departures from the ECNI model scheme which, in operation, make the NIAS draft equality scheme less robust. For example, NIAS has removed the commitment to seek input from stakeholders when reviewing its action plan (para 2.15) and to consult upon 'other matters relevant to the Section 75 statutory duties' (para 3.1). Also, the resources that will be committed to ensure s75 compliance have been qualified from 'necessary resources' to 'necessary and appropriate resources' (foreword).¹

¹ In addition, some absolute statements have been qualified to general commitments. For example, instead of 'providing' feedback in a timely manner and in suitable formats, NIAS is 'committed to providing' feedback in a timely manner and in suitable formats, which is a weaker obligation (see para 3.2.11). Similar use of 'committed to' has been added to para 2.14, on action measures, and para 6.8 on monitoring.



The ECNI model scheme represents a minimum of good practice, and we recommend that NIAS amend its draft equality scheme to reflect fully the ECNI model scheme.

In addition to these changes, CAJ recommends that NIAS include some additions, which would strengthen its draft equality scheme.

First, it would be helpful for consultees to be informed when screening forms are posted on the NIAS website. We are concerned that, as screening reports are sent to consultees on a quarterly basis (para 4.25), it is possible that civil society may not aware of a specific policy's screening for a period of three months. By this time, the policy may be implemented or further developed, so that alternative measures would be more difficult to apply. It would therefore be important for civil society to be informed sooner of policies for which 'no' or 'minor' impact was found, but for which they may have specialist knowledge of otherwise unforeseen equality impacts.

We appreciate that NIAS will make the screening forms available on its website and on request (para 4.13). However, given that there are over 200 designated public authorities in Northern Ireland, it is impossible to review each of those websites daily, or even weekly, to check if screening forms have been posted. We would therefore recommend that NIAS include a statement, at para 4.13, that consultees will be informed of screening forms when they are completed or posted on its website.

Secondly, CAJ recommends that NIAS include statements in its equality scheme to explain the operation of s75 Northern Ireland Act 1998 ('s75'), which is often misunderstood. In particular, the NIAS equality scheme does not explain the relationship between the equality duty (s75(1)) and the good relations duty (s75(2)). The ECNI Guide for Public Authorities² ('the ECNI Guide') clearly states that 'good relations cannot be based on inequality' and confirms that 'the term due regard was intended to be, and is, stronger than regard'.³ It also clarifies that 'the discharge of the good relations duty cannot be an alternative to or cannot set aside the equality of opportunity duty.'⁴

As the NIAS equality scheme will be used as a point of reference for its staff's application of s75 and any training provided, it is crucial that the equality scheme itself contains clear statements on the relationship and difference between the two s75 duties. Similarly, the ECNI Guide provides useful statements on positive action and multiple identities. We believe that the inclusion of these statements, or similar, would help staff to understand s75. For example, it is a common misunderstanding that 'universal application' implies a neutral impact on equality groups, when it can, of course, exacerbate inequalities.

The useful passages in the ECNI Guide are as follows: 'The promotion of equality of opportunity entails more than the elimination of discrimination. It requires proactive measures to be taken to facilitate the promotion of equality of opportunity between the categories identified in Section 75 (1). The equality duty should not deter a public authority from taking action to address disadvantage among particular sections of society – indeed such action may be an appropriate response to addressing inequalities. There is no conflict between the Section 75 statutory duties and other affirmative action measures or positive action measures which a public authority may undertake under anti-discrimination laws.'⁵

Finally, we would like to remind NIAS that, in addition to the s75 action-based plan, s75 continues to apply to all NIAS policies in relation to all nine equality groups. Although we recognise the positive impacts that the action-based plan could have on addressing inequalities, we are also aware that it could have a limiting influence on the operation of s75 outside the specific priorities identified within it. Also, newly emerging inequalities may not be captured in the original audit of inequalities. We therefore hope that any data gaps identified in the audit of inequalities will be addressed, and that the audit will provide a useful tool for policy-makers when applying s75 beyond the scope of the action-based plan.

At the same page, the ECNI Guide also states: 'Individuals do not neatly fit into one Section 75 category or another, individuals will invariably be members of a number of Section 75 categories. Thus Section 75 enables multiple identity issues to be considered as well as issues regarding particular categories of people.'
