As Glyndebourne Arts Trust is a registered charity (No. 208743) no inheritance tax is payable on the amount of your legacy. 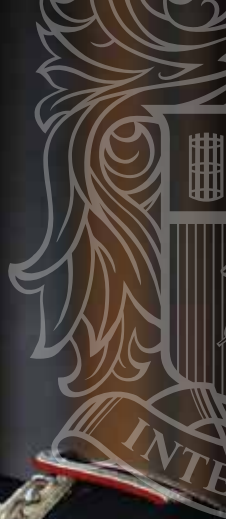
