# LOCATION

- The property is located on Ballymount Drive off Lower Ballymount Road.
- The estate is accessed via the Walkinstown Roundabout and the M50 Ballymount Interchange.
- Junction 9 & 10 are each approximately 2km from the property.
- The proximity to the M50 allows for quick access to all arterial routes including the N7 Naas Road.

#### DESCRIPTION

- Modern mid terrace industrial facility including 2 storey office accommodation with excellent profile fronting directly onto Ballymount Road Lower.
- Single span warehouse of precast concrete frame construction with double skin insulated metal deck roof and perspex roof lighting.
- Warehouse eaves height approximately 6.5 metres.
- Loading access via 2 electrically operated roller shutter doors.
- Two storey office accommodation incorporating plastered and painted walls, suspended ceilings, carpets, electric storage heaters, strip tube lighting and CAT 5 cabling.

The property is held under the terms of a 20 year lease from 1st September 2000. The current passing rent is €117,550 per annum.

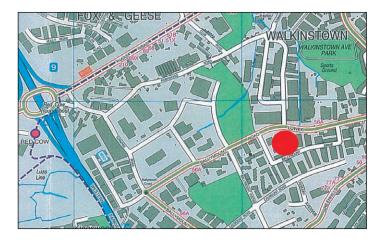
