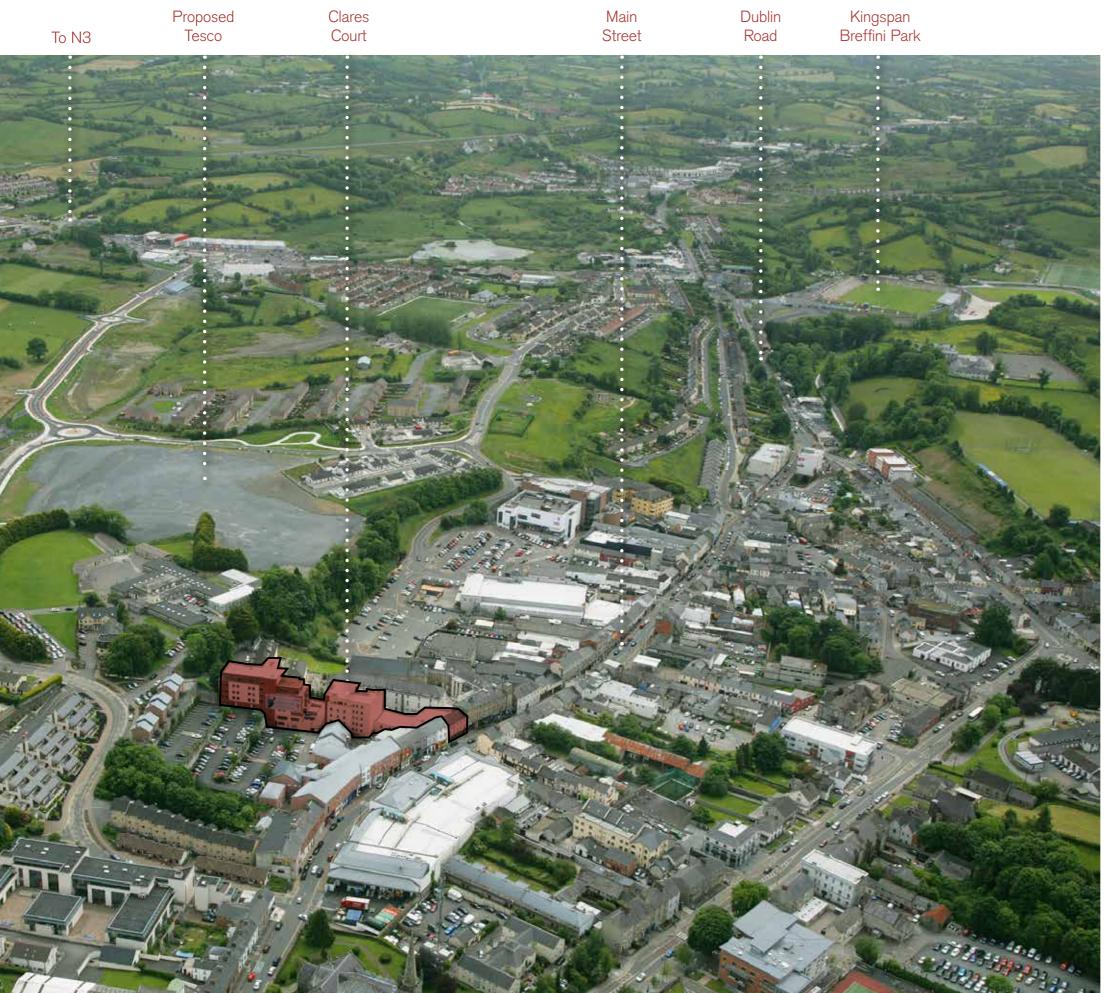

Residential Tenancy
Nineteen residential units are currently occupied and producing an annual gross rental income equivalent to approximately €102,000. We estimate that the ERV of the residential element, upon full occupancy, is approximately €186,000 per annum.

Access to the car park is via an archway from the main street through the New Court Centre Retail and Apartment development which leads to a gated entrance into Clares Court. Car parking is arranged over a number of floors in a multi-storey car park to the rear of the front block.



Location

Cavan Town has seen large development and expansion in recent years. There are approximately 30,000 people living within a 16 kilometre radius of the town. The town is located approximately 120 kilometres from Dublin, 142 kilometres from Belfast and 170 kilometres from Galway. Cavan is host to a range of amenities including restaurants, cafes, shops, licenced premises, Cavan General Hospital, nightclubs, a leisure centre, cinema, two 18-hole golf courses, Cavan Equestrian Centre and Cavan Institute.

The employment demographics in Cavan are diverse. They include Liberty Insurance, Abbott Laboratories, Global Indemnity plc, Glanbia and Kingspan Group.

The property is specifically located in Cavan Town Centre at the junction of the Main Street with Church Street opposite the Dunnes Stores Drapery Store and Supermarket Complex in the heart of the main shopping area of the town.
