







Citywest Offices

Citywest is a World Class business campus of 142 hectares (350 acres) located on the Naas Road Dual carriageway just to the west of Dublin. Citywest is specifically designed to meet the demanding requirements of leading companies in the distribution, manufacturing and service industries. With over 130 companies located in Citywest, Davy Hickey Properties, the developers, have designed the environment to facilitate their differing requirements by laying out the business campus in a number of distinct zones organised to locate like minded enterprises together.

Own Door Offices

Citywest now have 12 own door offices under construction bringing another dimension to the business campus.

Available in 2008 these offices will range in size from 165 m² to 409 m². Built to the highest modern standards, these third generation offices will incorporate generous car parking and first class landscaping. They have been designed specifically to suit the needs of domestic or international companies seeking to locate in a quality environment near Dublin with excellent transport links.


A Strategic Location

Citywest is strategically located on the Naas dual carriageway (N7) just 4km from the M50 motorway. This pivotal location brings the whole city to within a few minutes drive. It also gives occupiers the benefits of an urban setting without the drawbacks of traffic congestion, noise, etc.

With regard to public transport, there are few locations as well provided for as Citywest. The LUAS terminal and one of Dublin's largest bus hubs is located in nearby Tallaght where connections are available to the entire greater Dublin area and city centre. In addition to this, a regular private Citywest shuttle bus links the business campus with Tallaght. The LUAS red line will be extended to Citywest with a completion date of 2009, and the campus stop will be within a short stroll of the offices at Kingswood Road.


