LOCATION

The subject property is situated in the IDA Ireland Finisklin Business & Technology Park, an established IDA industrial estate located 1.1km northwest of Sligo City Centre. Sligo City itself is the commercial capital of the north-western region of Ireland and boasts international occupiers such as Abbot, AVA and Icon.

Sligo City is situated on the Garavogue River and is serviced by a number of national primary routes including the N17 to Galway (138 km) and the N4 to Dublin (216 km). Further access is provided via Sligo Airport, Knock Airport and Irish Rail.

More specifically the subject property is located approximately 0.7km from the main entrance to the Park. The property is adjoining high profile and well known occupiers such as Lindal Group, Litec Moulding Limited, Amcor, Elanco, Total Produce and Abbott.

DESCRIPTION

The subject property comprises a single storey industrial unit forming part of a block of four units, and has a floor area of approximately 464.5 sq m $\$ 5,000 sq ft. The property was built approximately 20 years ago of steel frame and concrete block construction,

double insulated clad roof and façade under a pitched clad roof. The property stands on its own private and secure site of 0.37 acres, of which a 0.26 acres comprises a concrete yard suitable used for car parking, deliveries or further development (subject to planning permission).

Internally, the property comprises 3 no. ground floor offices, kitchenette, ladies and gents toilets and a mezzanine floor with a board room $\$ office. The remaining floor area is used for general industrial use and has the benefit of an automatic roller shutter door measuring 4.3m high x 4.7m wide.
