#### Location

Unit 2 is located within the Comagh Business Park within the village of Kilbeggan, Co. Westmeath. Comagh Business Park is accessed off Comagh Road and the subject property is situated close to the entrance to the park while also enjoining frontage onto the main estate road. Other occupiers in the estate include Midland Mould & Engineering Ltd, Kilbeggan Roofing & Steel, Rafter Wood Products Ltd., Kelly Joinery Works Ltd, Quin-Lock Ltd. and Critical Healthcare.

Kilbeggan Village is positioned just off Exit 5 on the M6 Motorway providing easy access to Athlone (35km), Galway (119km) and Dublin (92km).

#### Description

The subject property comprises a modern, stand-alone industrial unit with three storey office accommodation to the front and two storey office accommodation within the warehouse. The unit is accessed by seven standard grade roller shutter doors and one half size roller shutter door. Internally the warehouse has gas fired heating, CCTV cameras, high bay sodium lighting.

The office accommodation to the front is in an unfinished state with no lighting, flooring or suspended ceilings in place. The two storey office accommodation within the main warehouse section provides cellular offices and a canteen. There is also a stand-alone first floor mezzanine level.
