DUN LAOGHAIRE

Located in south county Dublin, Dun Laoghaire is an established affluent coastal suburb situated approximately 13 kms from Dublin city centre.

The town is thriving commercial centre and is the administrative hub of the Dun Laoghaire Rathdown local authority area which covers the majority of Dublin's southern suburbs including the affluent areas of Sandycove, Dalkey, Monkstown, Blackrock Deansgrange.

The town is well served by bus and rail links and is easily accessed by private car. It also has a busy port terminal at Dun Laoghaire Harbour.

George's Street Upper is the primary retail thoroughfare in Dun Laoghaire, anchored by Bloomfields Shopping Centre to the west and to the east by Dun Laoghaire Shopping Centre.

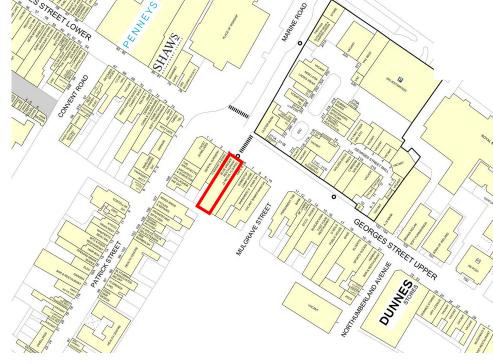
No. 5 Georges Street Upper is positioned in the prime location on the street opposite Dun Laoghaire Shopping Centre and close to Penney's and Shaws.

DESCRIPTION

- No. 5 Georges Street Upper comprises a three storey mid terrace period property of traditional construction, with glazing at ground level and redbrick facade at the upper levels.
- The property is laid out to provide café/restaurant and kitchen at ground floor, with independent ground floor access leading to a first floor restaurant with its own kitchen and WC facilities. The second floor is currently in use as ancillary storage.
- The entire extends to a total gross floor area of 392.9 sq m (4,231 sq ft).
