LOCATION

- The property is situated 300 m. from the southside of the Naas Road (N7) between the M50 and Newlands
- The property is approximately 1.2 km from the M50 / Red Cow Interchange (Junction 9) providing swift access to all the main arterial routes serving Dublin, Dublin Port and Dublin Airport.
- The property is situated to the rear of the well known former SDS facility and next door to Heiton Buckley.
- The LUAS Park & Ride facility is within walking distance of the property and this links the city centre with Tallaght Town Centre and a new extension to City West is to open shortly.



DESCRIPTION

- The building has been used historically for fabrication and would suit a wide variety of intensive industrial
- The building is of concrete portal frame construction with concrete block walls to approximately 2 m. and from there to eaves height with profile steel cladding.
- There is a reinforced concrete floor and a single skin cement fibre roof.
- The building was extended by approximately 7 m. and the roof of this section is finished in metal decking.
- The clear internal height is approximately 3.7 m. with an apex height of approximately 6 m.
- Loading access is to the front of the building via a steel roller shutter door 3.6 m. wide x 5 m. high.
- Basic office accommodation is provided to the front of the building.
- There is a substantial gated and fenced yard which is mainly surfaced in hardcore, but with a concrete apron to the front of the building.
