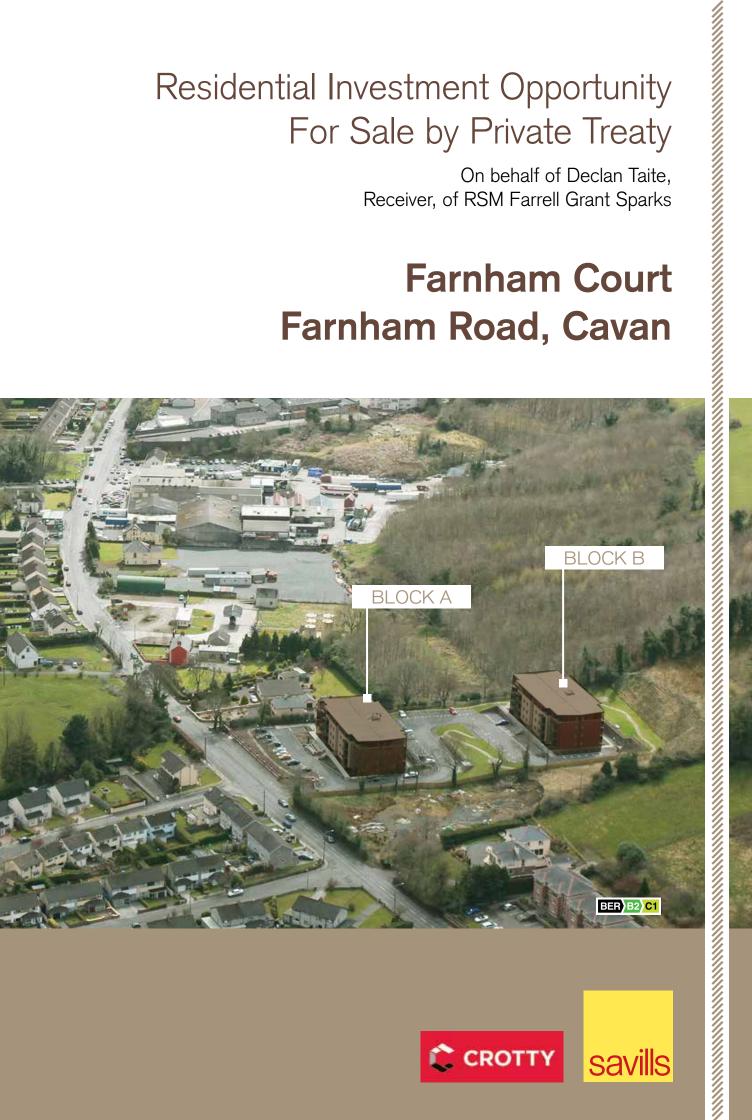

## Description

The subject property comprises an attractive multi-unit residential development containing 58 apartments of a 60 unit development.

The property is laid out in two blocks, which are situated on approximately 0.93 hectares (2.3 Acres). The blocks are nicely set back off the main road and offer attractive views over the surrounding countryside.

The site rises gently from the main road with an internal tarmacadam driveway winding its way around the two blocks and providing access to designated surface parking areas along the way.

The grounds are superbly landscaped and maintained and the site benefits greatly from its mature setting among timber stands which provide scale to the blocks and allows this relatively new development to blend in with its surroundings.

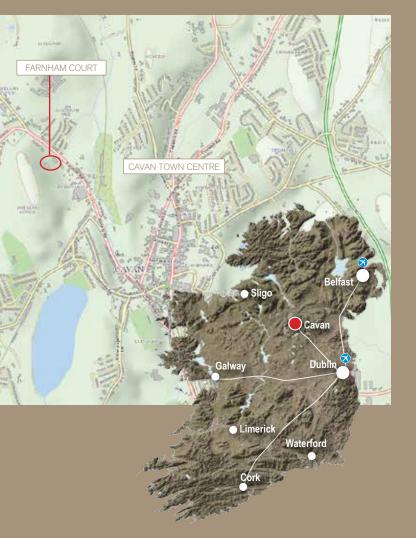

29 of the 30 units within Block A are currently occupied and producing an annual rental income equivalent to approximately €149,400.

The rear block is currently vacant as all units are currently unfurnished. The ERV of the entire property (58 units) is approximately €298,800 per annum.

### Location

Cavan Town has seen large development and expansion in recent years. There are approximately 30,000 people living within a 16 km radius of the town. The town is located approximately 123 kilometers from Dublin, 142 kilometers from Belfast and 170 kilometers from Galway.

Cavan is host to a range of amenities including restaurants, cafes, shops, licensed premises, Cavan General Hospital, nightclubs, a leisure centre, cinema, two 18 - hole golf courses, Cavan Equestrian Centre and Cavan Institute.

The employment demographics in Cavan are diverse. They include Liberty Insurance Abbott Laboratories, Global Indemnity Plc, Glanbia and Kingspan Group.

The property is specifically located on the Farnham Road, just north-west of Cavan Town. The surrounding area predominately comprises of one off residential developments and low density housing estates. The property is also located approximately 350m from Cavan General Hospital.
