Putting housing on the health and care agenda

In February, the Health Select Committee published its report from its inquiry into social care. Federation chief executive, David Orr, met with Stephen Dorrell during the inquiry and the Federation provided written and oral evidence to the committee. We were pleased to see the committee endorse our central point in the need to integrate housing with health and care, to deliver the range of interventions we need.

The Federation has argued that it is impossible to improve an individual's care without ensuring they have settled accommodation as part of that package. The home is an effective and increasingly popular delivery channel for services. Closer working between housing, health and social care means that older and vulnerable people can be offered personalised, flexible, high-quality services, and communities can deliver effective public health improvements. The select committee report quotes Federation evidence on several different issues, including its main recommendation, which is for more ambitious integration to connect health and care with housing. The committee concluded that:

'NHS organisations that "salami slice" services and fail to integrate with housing and social care could have very serious consequences for standards in both health and social care.'

The Social Care White Paper is expected in May. The Federation is meeting with officials to build the strength of the narrative on housing throughout the White Paper. The Federation is meeting with officials to provide input on links with housing. David Orr has met Liz Kendall MP, Shadow Minister for Care and Older People, to

discuss the opportunities to look at housing and care in the home to improve offers to older people.

Lobbying on the Health and Social Care Bill

The Federation has been actively lobbying peers during the House of Lords committee and report stages of the Health and Social Care Bill. At the committee stage, we had five joint amendments debated. These amendments included:

- Testing where duties to reduce health inequalities for the most vulnerable take effect in the new health svstem
- Pressing for the inclusion of voices on housing and homelessness in the new local structures, health and wellbeing boards and Joint Strategic Needs Assessments (JSNA).

We have worked jointly with NCB, the children's charity, St. Mungo's and Homeless Link to push forward a range of amendments to the bill. At report stage, joint amendments on duties on local boards to integrate health and care with health-related services like housing and education, were discussed on Thursday 8 March. Beyond the bill, we have provided written feedback to the Department of Health (DH) on its draft guidance on local needs assessment and health and wellbeing strategies. This focused on the importance of making strong links with housing, looking at practical opportunities to do this through

its approach to integration of needs assessment and commissioning. There is some promising responses to our lobbying. The draft guidance does recognise housing as a key determinant of health outcomes, as well as a potential contributor to the JSNA and sector to which health and wellbeing boards can extend membership. We have also published a briefing for health commissioners with the NHS Confederation on the practical opportunities to using housing and support to improve mental health outcomes.

Changing housing benefit rules for communal areas

The DWP has conducted an informal exercise to collect information about the recovery of charges for communal areas in supported housing in response to an upper tribunal decision (CH/322/2011). Regulations state that these costs are eligible for benefit in sheltered housing and the Federation has raised concerns with the DWP, that there are serious and damaging consequences to any change in the longstanding local practice to regard these as eligible charges in supported living projects.

A number of Federation members submitted evidence to show the serious short-fall tenants would face if these charges became ineligible, and the lack of meaningful control tenants have over heating, lighting and cleaning of communal areas. The Federation pulled together members concerns and provided some national figures to the Department. The DWP is now considering this evidence. Any change in regulations will go before the Social Security Advisory committee for consultation.

Welfare Reform Act 2012

The Welfare Reform Act ushers in the biggest change to the benefits system in 60 years. It sets out the framework for the universal credit, though much of detail will come in regulations. For briefings on parts of the act affecting the payment of benefit to cover housing costs see:

During the debate on the size criteria for social housing, we received a ministerial assurance that

people living in supported and sheltered housing would 'not be affected by this measure'.

On housing benefit in supported housing, the Government is still considering the responses it received to its consultation about reforming exempt accommodation and replacing it with new eligibility rules. The Federation is calling for a comprehensive response to the submissions received and further consultation on specific proposals.

Breaking the mould of older people's housing - support to manage transitions

Following our high profile Breaking the mould report, we are publishing examples of housing associations delivering health and care outcomes for older people by helping individuals to navigate transition points in their lives. This project, supported by the Housing Learning and Improvement Network will feature case studies from members on themes such as intermediate care, end-of-life care, supporting people with dementia and maximising the benefits of telehealth and telecare.

The results of the project will be published online later in the spring. The case studies and briefing will communicate to commissioners how housing models improve older people's care pathways, deliver better outcomes and achieve cost savings. The case studies will offer valuable insights and learning for members on working more closely with health partners and assist them to meet rising customer expectations and make better use of underutilised stock. Housing Adaptations update

The Federation supports and promotes good practice in delivering aids and adaptations. The Department for Communities and Local Government (DCLG) has recently established a Disabled Facilities Grant (DFG) working group. Caroline Hawkings is part of the group for the Federation and other members include Foundations, the Royal College of Occupational Therapists and a small number of local authorities. Its primary focus is on how the DCLG can improve processes and delivery of DFGs.

The Federation held a successful Adaptations conference on Wednesday 7 March in London. Its focus was on improving delivery, outcomes and cost effectiveness in a rapidly changing health and social care context. Voted 'the best adaptations conference' by one of the delegates, the day included lively debate with high profile speakers from the DCLG and local government, and a range of practical breakout sessions from proactive asset management to supporting people with dementia.

The genHOME project on housing adaptation is a new research initiative being led by York St John University. This three-year study aims to develop a methodology to evaluate the effectiveness of housing adaptations and solutions for disabled people, by reviewing and mapping existing research. It will include working with occupational therapists working in the clinical area of housing and other stakeholders to create an accessible information database. Payment by results scheme to tackle rough sleeping in London

The DCLG and the London Mayor's Delivery Board have launched a £5m payment-by-results social impact bond to tackle persistent rough sleeping in London, to be run by the GLA. In line with the principles of social investment, provider charities involved will be paid on the basis of outcomes delivered. The outcomes the funding will be assessed against reducing the proportion of regular rough sleepers returning to London's streets; reducing admissions to hospital and Accident and Emergency; and increasing the number of rough sleepers moved into settled accommodation and employment. New pension obligations: implications for people with carers or personal assistants

People employing personal assistants or carers using direct payments will have new pension Starting from 2012, the largest employers will need to automatically enroll eligible workers into a qualifying workplace pension scheme. However, although automatic enrolment will start to be phased in this year, employers with less than 50 employees will not be brought into automatic enrolment until 2015 at the earliest. Where an individual employs people directly to assist with their care, they will need to comply with this obligation. The Pensions Regulator (TPR) will be writing to all employers to let them know when they will need to begin automatically enrolling their workers.

The DWP has produced a Workplace Pension toolkit, which provides some basic and straightforward information on automatic enrolment. There is a basic facts booklet, case studies and signposting through contacts pages, to other websites providing further information on automatic enrolment for

Three million lives campaign to extend the reach of telehealth and telecare

At least three million people in the UK, with long-term conditions and/or social care needs, could benefit from using telehealth and telecare, according to estimates by the DH. Using equipment installed in a person's home. telehealth involves remote monitoring of vital health signs, and telecare uses personal and environmental sensors that enable people to live safely and independently for longer.

The DH has launched a campaign: Three million lives, designed to promote partnership working with industry, the NHS, social care and professional partners, in order to stimulate capital investment. This includes a Concordat between the DH and the telecare and telehealth industry.

The DH has also released headline findings from its Whole system demonstrator programme. This randomised control trial of 6,000 people aims to provide a clear evidence base to inform future investment decisions. and to show how telehealth and telecare supports people to live independently and take more control over managing their health. Headline findings from December 2011 show that, if delivered properly, telehealth can achieve a 15% reduction in A&E visits, a 20% reduction in emergency admissions, a 14% reduction in elective admissions, a 14% reduction in bed days and an 8% reduction in tariff costs.

How will we develop new supported accommodation? **The Federation's Funding Future**Homes project

The Federation is working with its members on a research project on the future funding models for development. This project is based on initial research from the Cambridge Centre for Housing and Planning Research (CCHPR), and policy analysis by the Federation. Between January and February, regional member discussion events took place, supplemented by stakeholder interviews and thematic roundtable discussions. This included a roundtable discussion on future funding models for supported and specialist housing. The final output will be a lobbying and influencing document based on our evidence and the responses of stakeholders and members to it. This will form the basis of the Federation's lobbying and influencing of Government post 2015. Better planning for older people

Local authorities should work with their partners to develop housing with care strategies that deliver a range of specialist housing choices for older people, according to a resource pack published recently. Strategic housing for older people: planning, designing and delivering housing that older people want, is published by the Housing Learning & Improvement Network (Housing LIN) in association with the Association of Directors of Adult Social Services. It is intended to help councils identify local supply and demand for various types of housing and the support needs of their older people. It also includes practical advice on a range of factors that influence the development of housing with care, from commissioning and funding to planning consent and marketing individual schemes. This pack aims to help partners in the public, voluntary and private sectors work together to provide housing that older people actually want to live in. Community Budget pilots move ahead

At the end of 2011, DCLG announced the areas selected to take forward the Community Budget whole area and neighbourhood level projects. Four areas have been selected for the whole area approach, twice as many as first planned, to run a Community Budget next year focusing on ways to create local growth and reduce dependency on the state. They are Cheshire West and Chester, Essex, Greater Manchester, and the tri-borough partnership of Hammersmith & Fulham, Kensington & Chelsea, and Westminster.

Ten areas, again more than originally planned, have been selected to take forward the neighbourhood level community budget work.

They are

- Hammersmith & Fulham Tower Hamlets
- Bradford Trident
- Kingston
- Birmingham
- Ilfracombe

- Tunbridge Wells
- Haverhill
- Westminster
- Newcastle

Helping older people choose the right home for them

EAC/FirstStop has produced a report examining a range of approaches to helping older people make informed decisions about their housing options. It explores the outcomes and financial benefits of different services for older people and how these contribute to making the most effective use of housing

stock. The projects include a Homeshare service, the Free Space pilot scheme (where home owners use equity on their homes to rent it out and downsize to more suitable accommodation), and a Care & Repair and home relocation service.

Evaluation of handypersons schemes

shown that the small changes made by handyperson services can make a big difference to the independence of older people. The evaluation concludes that handypersons services offer an important safety net for older people, and they also enhance the effectiveness of health and social care provision through simple and very low cost interventions. Services are consistently highly rated by people who use them, and they are valued for their trustworthiness, reliability, quality, and crucially for the skills and respectful attitudes of the staff. The evaluation adopted a number of different methods including a literature review, surveys of local authorities, service providers and service users, and case studies focusing on a number of different services. Based on conservative modelling assumptions, the benefits achieved by the handyperson programme outweighed the costs of providing the programme by 13%. The biggest costs that can be avoided are in social services.

Health for Living - a new housing partnership for health

The Accord group has launched a new consortium called Health for Living, which brings together a range of housing and health partner organisations to improve the health and wellbeing of people in Sandwell. The consortium's key members are Black Country Housing Group, Murray Hall Community Trust and Sandwell Mind.

Health for Living has secured a £1.2m contract from Sandwell PCT to roll out a confidence and wellbeing service for people with long-term illnesses. The service includes health improvement programmes, help and support to assist people to manage their own conditions, stress and relaxation workshops, and food and mood activities. An online self-help tool will also be launched as part of the contract to offer people vital advice and support about managing different health conditions, ranging from anxiety management to weight management.

Equity release and older home-owners

The Joseph Rowntree Foundation has published an assessment of three pilot equity release schemes for older home-owners receiving Pension Credit. Three local authorities have tested an equity release product between 2010/11. The Home Cash Plan aims to provide small amounts of equity without any adverse impact on benefits. The product was

originally developed by Just Retirement and is now offered nationally through Age UK Enterprises and FirstStop. The report provide honest learning about the challenges of equity release and the importance of timely and relevant financial advice for older homeowners to make this work and alter the perception of drawing on the value of their home.

What can we learn from community buying? The Buy **Better Together** Challenge

New tool for housing providers to support residents with sight loss

The Thomas Pocklington Trust have launched 'Evolve-for vision' a new assessment-based tool to help housing providers improve the quality of life for older people losing their sight.

The new tool is based on extensive research examining the quality of life of older people living in extra care housing. This found that buildings did not provide the full range of sensory support to enable people to live independently. Following this, Thomas Pocklington Trust funded a further study to look specifically at the needs of people with sight loss and to develop a specialist tool that could test buildings on their performance for this specific group. Evolve-for vision has a room-by-room checklist highlights almost 400 design features relevant to quality of life for older people with sight loss.
