This document is only applicable to those practices which also dispense. You must have a valid PCRS certificate on your machine in order to export the monthly dispensing listing directly to the PCRS.

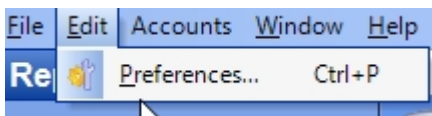

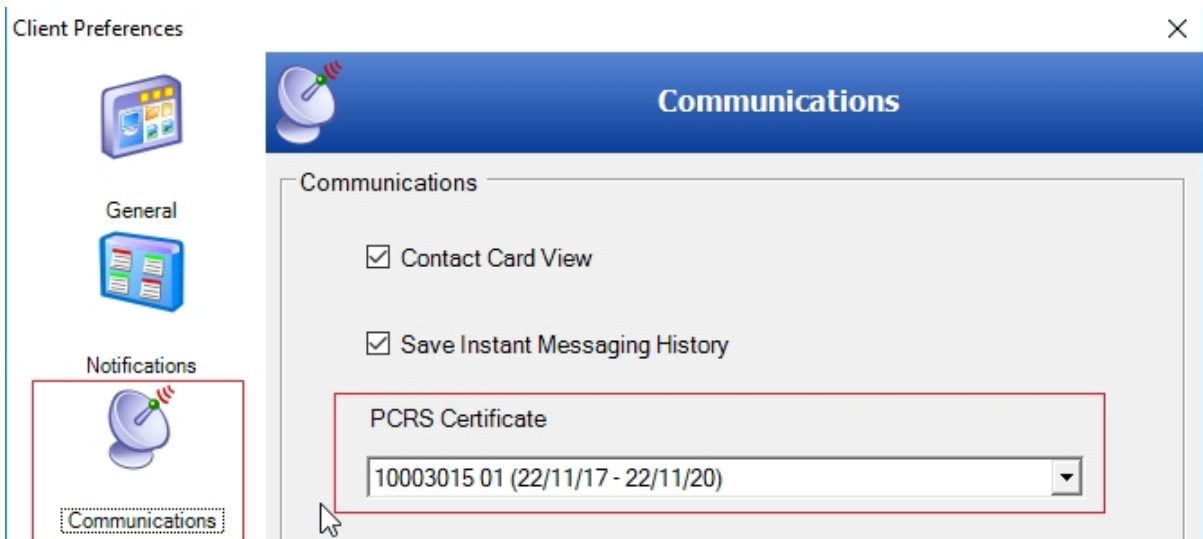

1 PCRS Certificate

Select Edit > Preferences from the main menu.



Select **Communications** and select the valid PCRS certificate from the dropdown list and click **OK** to save your changes.



2 Patient Registration

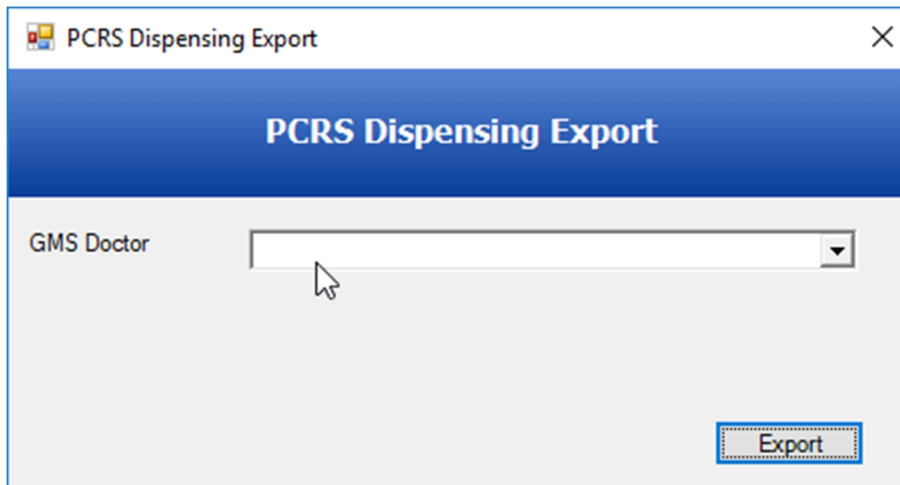
4 Export to PCRS

Select Dispensing Export in the Report menu to export the monthly dispensing list to the PCRS.

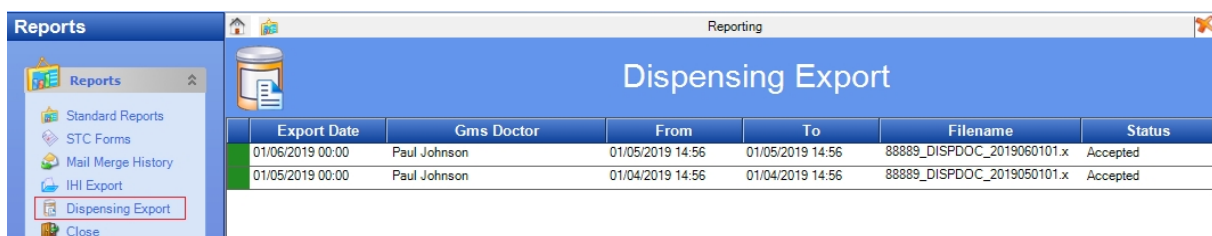
Click **New Export** to complete the export for the **previous month** and select the GMS Doctor from the dropdown list. This step must be completed for each doctor separately.



If you do not have your default PCRS certificate set in Client Preferences, you will receive this message.



Once the export is complete it will be displayed in the list. A green status icon shows that the file was delivered to the PCRS. If the status icon is red, the Status column will display the reason the file was not submitted to the PCRS.
