
1. Job Purpose

Principal Accountabilities

CBM Trainees will be trained and mentored by competent AVT personnel to deliver, by the end of their training period:

- 3.1. Collect and analyse data utilising various condition monitoring techniques (electrical and mechanical) and formulate accurate and concise reports to the client, clearly identifying any potential failure modes and risk of client business impact.
- 3.2. Provision of Lubrication Management services where required as per AVT SOP's.
- 3.3. Reporting; first and second pass analysis (where qualified/proficient) of CBM results ensuring any potential threat to clients reliability program is identified and reported. Liaison with Senior AVT/AES Engineers for peer review where required.
- 3.4. Be aware of the Asset Management Directors business plan, promotion of AVT/AES group services when interacting with clients or see opportunity to cross sell.
- 3.5. Deliver specific asset management services to improve client's equipment availability & reliability as directed by Operations Management teams.
- 3.6. Ensure services are competently delivered on time, in accordance with approved AVT/AES technical, operational, and HSEQ standards.
- 3.7. Ensure effective communication and reporting to line management with regard to operational objectives, achievements and opportunities or risk.
- 3.8. Co-operate with AVT/AES peers to support future business development. Advise AVT/AES Management of potential new business opportunities.
- 3.9. Assist in compiling, manage and follow Method Statements, COSHH Assessments, Risk Assessments and SOPs in place, inform Management if documentation is incorrect or missing and report any HSEQ issues.
- 3.10. Demonstrate to the client that a high level of service is being delivered in a professional manner at all times
- 3.11. Be responsible for own work, organising the delivery of all specified site services, assisting the Site/Regional Team Manager to optimise performance, in compliance with all business systems, processes and standards.
- 3.12. Ensure equipment and facilities are maintained in a serviceable condition and within the calibration QAP control procedure
- 3.13. Follow the AVT Staff Handbook and specific Client HSEQ systems are followed strictly.
