## Location

The property is located fronting Rochdale Road in Royton, Oldham and is situated opposite Co-Op and Lidl superstores and is located approximately 2.5 miles from Oldham town centre and 4 miles from the M60 motorway.

## Description/Accommodation

The property provides a three storey commercial investment property of traditional construction under a pitched slate roof with external yard areas. The property provides a ground floor restaurant/takeaway with Natwest ATM and the first floor provides office accommodation.

Ground floor: 810 Sq.ft overall comprising main sales, rear prep room, storage/kitchen/fridges, rear toilet facilities and access to the 356 Sq.ft cellar.

First floor: 727 Sq.ft overall comprising two front offices, meeting/board room, central server/copy room, landing and access to toilet facilities.

Ground floor ATM: 96 Sq.ft.

To the rear is a private gated loading yard with car parking for the takeaway premises and there is access to a free Council car park accessed off Park Street.
