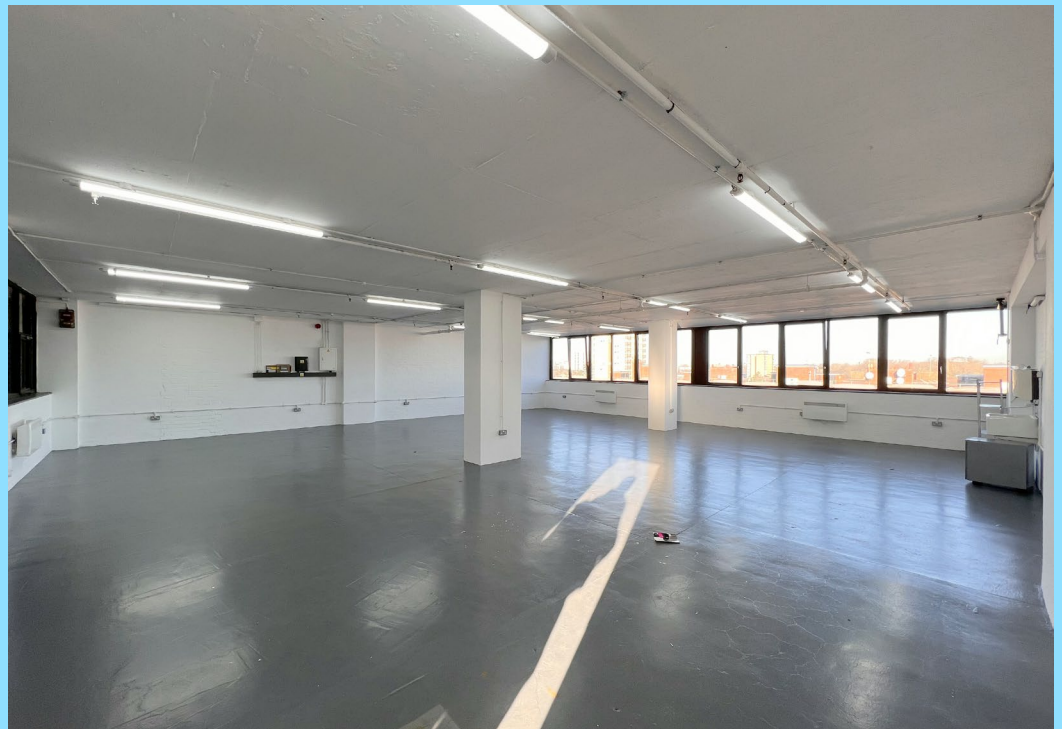
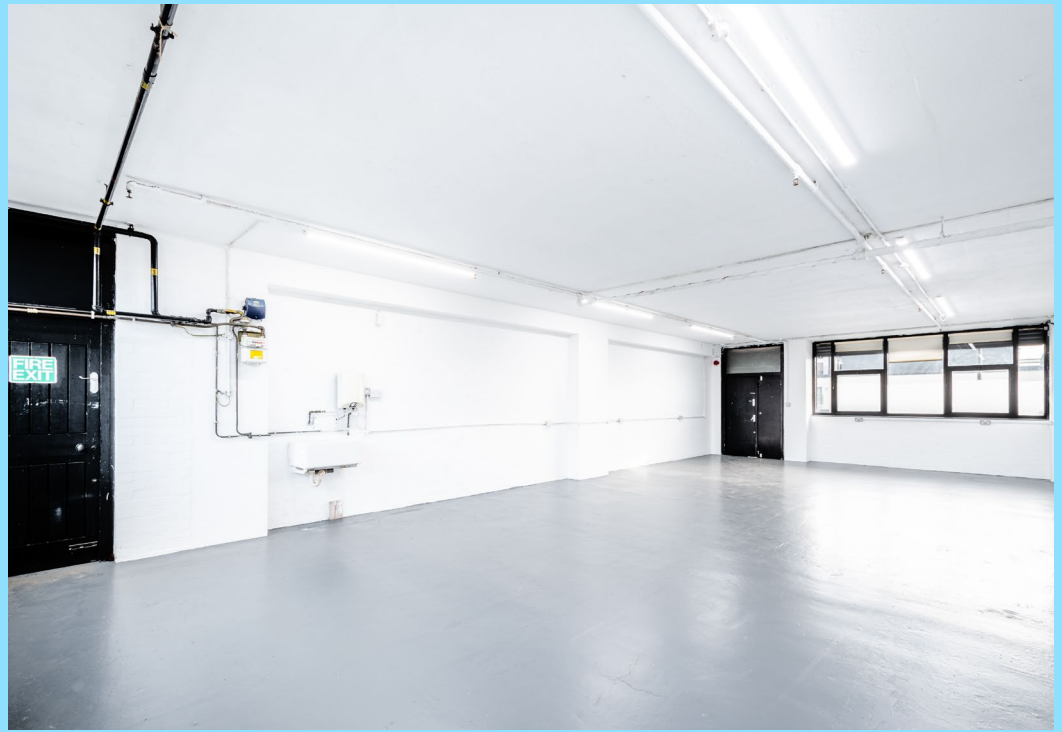
DESCRIPTION

LOCATION

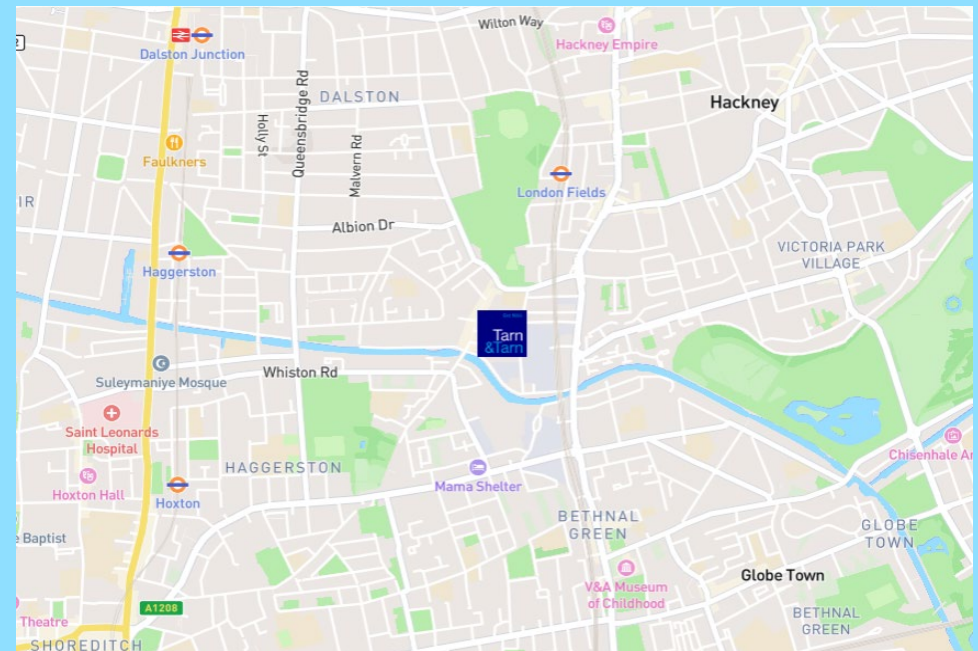
THE AREA
