LOCATION

The property occupies a prominent position fronting Lancaster Road in a well-established commercial/industrial location approximately 3 miles north of Shrewsbury Town Centre and 1 mile from the A5 Shrewsbury Bypass. Occupiers in the immediate vicinity include a mix of retail, trade counter and motor trade operators including Alan Ward Furniture, Howdens and ATS Tyre Centre.

Shrewsbury is the county town and main administrative centre of Shropshire and is located at the intersection of the main A5 and A49 trunk roads approximately 12 miles west of Telford, 45 miles north west of Birmingham and 45 miles east of Chester.





DESCRIPTION

The buildings are currently a mix of single and one storey industrial and office accommodation which is detached with secure yard and parking facilities to the front and side of the buildings.

The properties are brick construction under a mixture of flat and sawtooth roofs. The buildings are PVC double glazed with pedestrian access and roller shutters.

The offices have the benefit of central heating. The eaves heights range between 3.2 and 3.8 metres.
