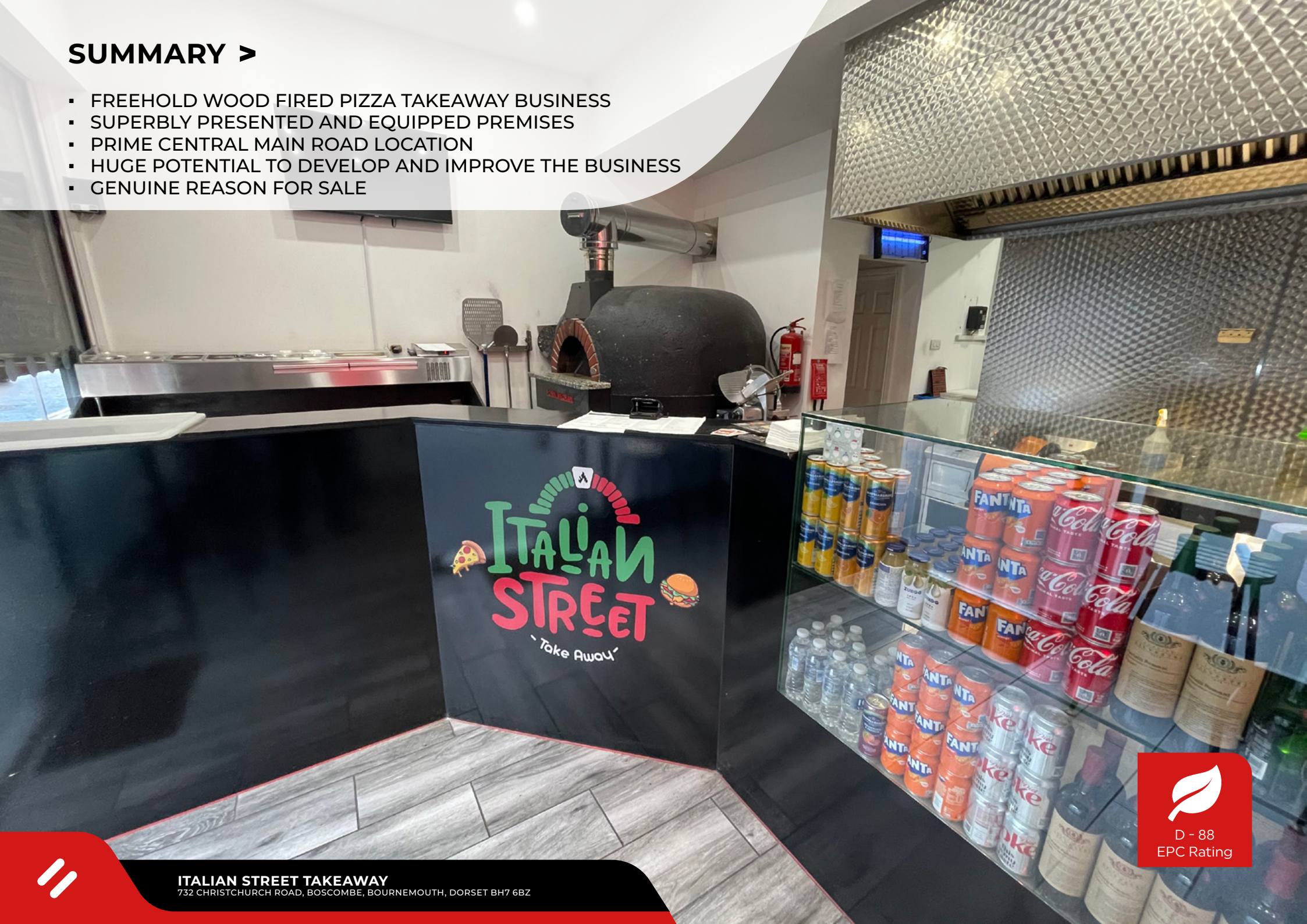

## Location

Prominent main road location with passing foot and road traffic. Located amidst shops and businesses. Situated in an area of dense residential housing.

## Description

Through door into **Takeaway** with laminated flooring, 2 high tables, 4 high chairs, inset ceiling lighting, wooden server counter, built in glass fronted chiller display cabinet, wall mounted flat screen television, CCTV cameras, CCTV display screen, fire alarm control panel, Sam 4S customer ordering touch screen machine. Through into **Kitchen** with double glass fronted chiller display, 2 stainless steel tables, double pizza oven, extensive extraction system, charcoal grill, Blueseal commercial griddle, small electric griddle, 2 double Caterlite electric hob, chiller counter unit with 3 cupboards and a chilled topping dispenser above, wood fired Forni Valoriani wood fired pizza oven, small stainless steel table, double deep fat fryer, cupboard under, meat slicer. Through into **Wash Up/Store Room** with insectocutor, 3 stainless steel tables, double deep bowl single drainer stainless steel sink unit, shelving, upright Arctic freezer, upright double Arctic fridge, Moretti Forni double pizza oven, extraction above. Through into **Lobby**. Through door to the side of the property. Through door into **Staff Cloakroom** with low level WC, wash hand basin, electric hand dryer, extractor fan. OUTSIDE To the front of the property there is an electric roller shutter. To the rear of the property there is a bin store area.

## Trading & Business

The owners inform us that the takeaway currently operates from 5pm until 10pm Tuesday to Thursday inclusive and 5pm until 11pm Friday to Sunday inclusive. The business was started by the current owners and fully fitted and equipped to an extremely high standard approximately 2 years ago. The current owners feel that there is huge potential to develop the business further by operating longer hours and offering further food lines in addition to wood fired pizza. Accounts can be made available to genuinely interested purchasers.

## Licences/Permissions

We are informed that the property holds a Premises Licence granted by BCP Council (Bournemouth). The Licensing Act 2003 states that properties serving alcohol have a designated premises supervisor who must hold a Personal Licence. We suggest that all purchasers take appropriate professional advice. We have not had sight of this licensing documentation.

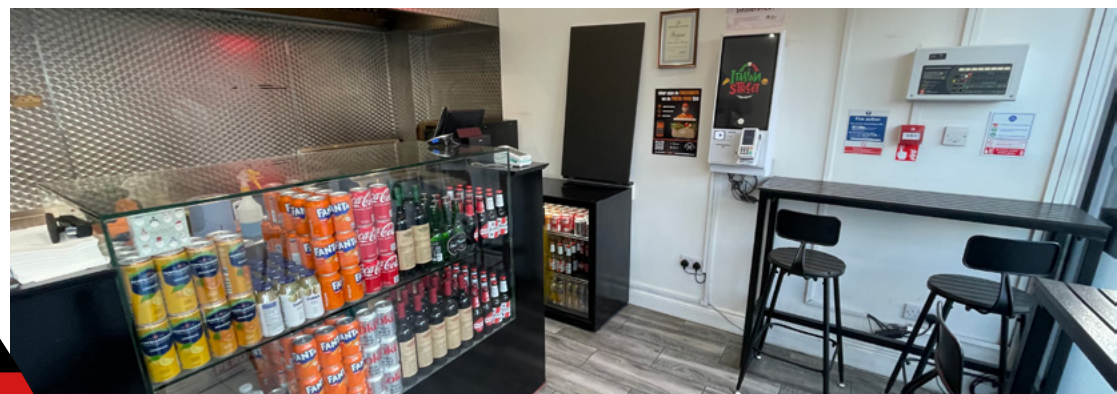
