The property comprises a mid terrace, steel portal frame unit with brick elevations and a pitched roof. There is a ground level roller shutter door accessed from the yard on the front elevation, along with a pedestrian entrance opening into a reception area. The property benefits from 5m eaves, 3 phase electricity, male and female WCs and allocated parking.

#### Location

Elgin Industrial Estate is located 1.5 miles north east of Swindon town centre. Swindon is well located on the M4 with access taken from Junctions 15 and 16. To the east is the A419 dual carriageway which provides a route north and south.
