
LOCATION


THE LAND AND OPEN ARCHES


The arches open onto further secure land bounded by the railway viaducts and accessed via double gates off Valentia Place. There is a further small, enclosed arch which provides dry storage.

The arches have B8 planning, suitable for storage use. Other uses may be considered subject to planning permission.
