



Midhurst is a town in the county of West Sussex approximately 10 miles to the south of Haslemere, 12 miles north of Chichester, 28 miles north-east of Portsmouth and 55 miles south-west of central London.

The town is 10 miles from the east of the A3 trunk road, which is accessed via the A286 and A272, which connects Midhurst to Portsmouth and Guildford. The A286 to the south of the town connects to the A27, which provides excellent access to Junction 12 of the M27 motorway.

The nearest railway station is in Haslemere, a 20-minute drive, which has regular train services to London Waterloo station with an average journey time of 58 minutes.
