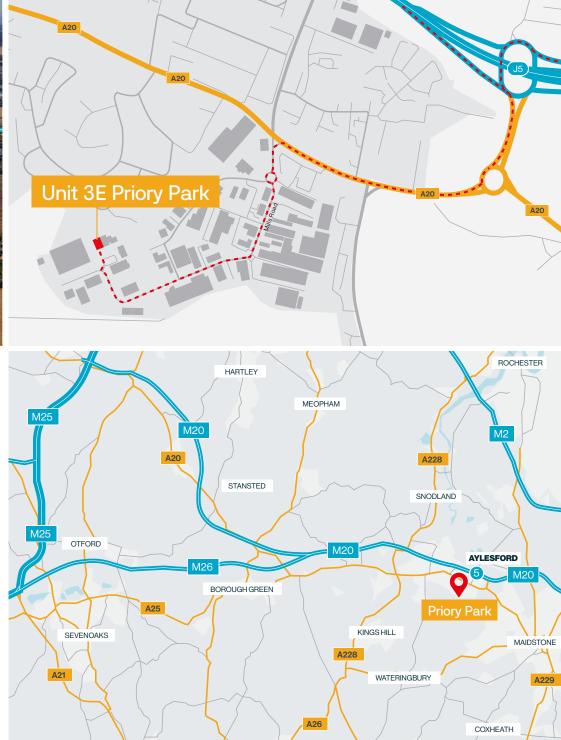


Aylesford is a well-connected town in Kent, approximately 30 miles south-east of London and just 3.5 miles north-west of Maidstone.
