LOCATION

The property is very prominently located at the junction of Corve Street and Station Road on the edge of the town centre of Ludlow. The property is located in close proximity to Tesco, Ludlow railway station, Lidl and Ludlow Brewing Company. The property is located on the northern edge of the town centre and in proximity of all local amenities.

Ludlow is an established market town and is the administrative centre serving South Shropshire. The town has all local amenities and benefits from being an established tourist centre.

Ludlow has a population of circa 11,000, and is located approximately 34 miles from Shrewsbury and approximately 24 miles from Hereford.

DESCRIPTION

The property offers the rare opportunity to let a prominently located site on the edge of Ludlow town centre. The property has been in use for a number of years for car sales but would lend itself to a variety of commercial uses (subject to statutory consents).

The property comprises a commercial unit that has a Total Gross Internal Floor Area of approximately 774 ft sq (71.9 m sq) and in front of the unit a forecourt area/ yard area that is of level aspect and surfaced and has been used for car sales.

The property is accessed from Corve Street and enjoys a very prominent location with road frontages onto Corve Street and Station Road.

TENURE

The property is offered to let on a new lease for a length of term by negotiation. There will be rent reviews at 3 yearly intervals and the lease will be granted on Tenants Full Repairing and Insuring terms.
