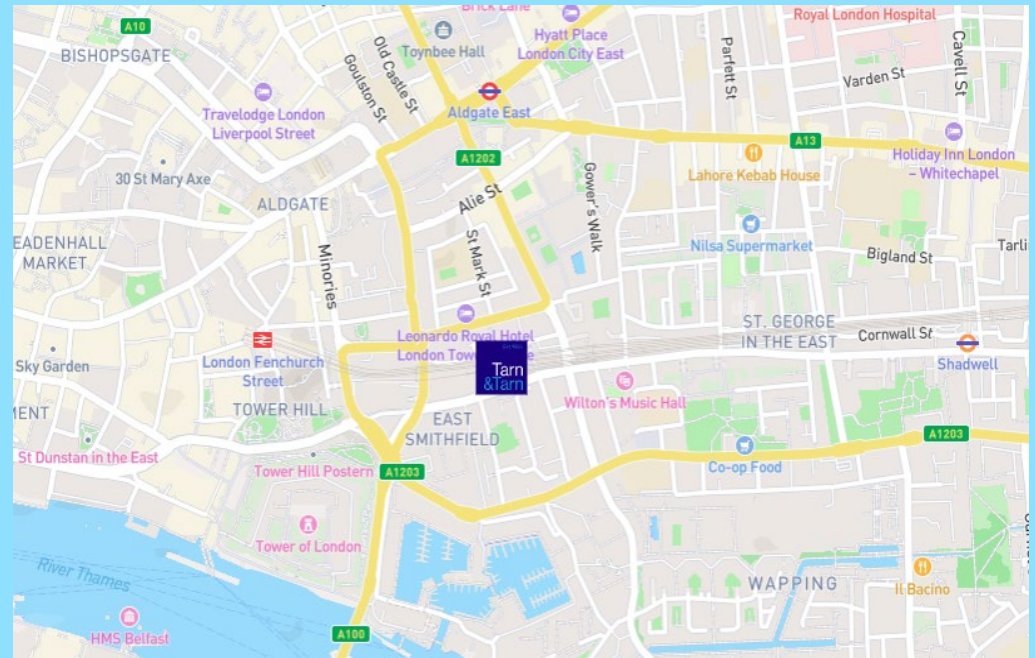
THE AREA
