The property is a detached former residential farmhouse converted in circa 2000 to high quality office accommodation with vaulted ceilings and full height atrium with full width glazing panels and velux windows. The accommodation extends over two storeys with the ground floor separated into an open plan work area, a separate large break out / kitchen area, plus male and female WCs, disabled toilet, and shower. The first floor is an open plan floor plate apart from a server room and storage built into the eaves on one side of the building.
