Location

The property occupies a sought after and prominent location on Wyle Cop, being the main pedestrian and traffic route into Shrewsbury Town Centre from English Bridge. Wyle Cop is a popular shopping area within the town supporting a wide range of independent and boutique retailers including fashion, beauty, jewellery and other specialist uses with the St. Julian's public car parks nearby.

Shrewsbury is the County Town and Administrative Centre of Shropshire, strategically located at the intersection of the main A49 and A5 trunk roads, approximately 47 miles north west of Birmingham, 15 miles west of Telford and 40 miles south of Chester.

Description

The property comprises a well-appointed retail/leisure premises extending in total to approx. 2,224 sqft (206.7 sqm) having been recently refurbished. The property provides open plan retail accommodation with separate storage facilities, benefitting from a long frontage onto Wyle Cop incorporating large display windows.

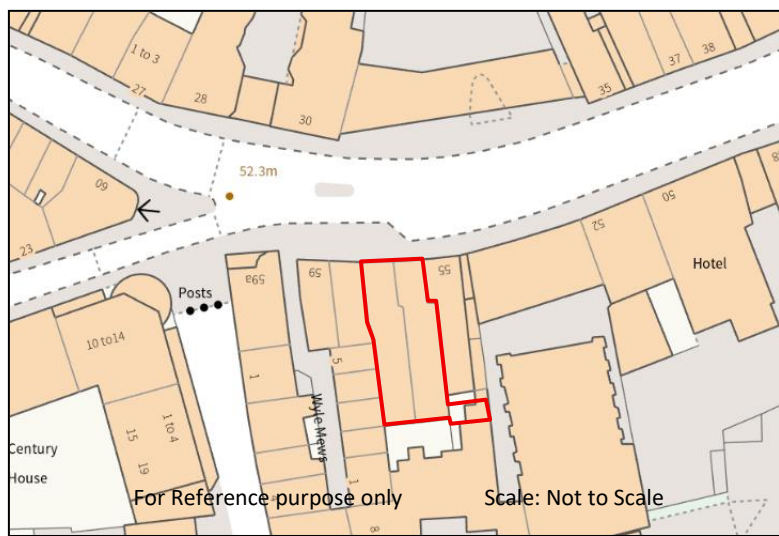
