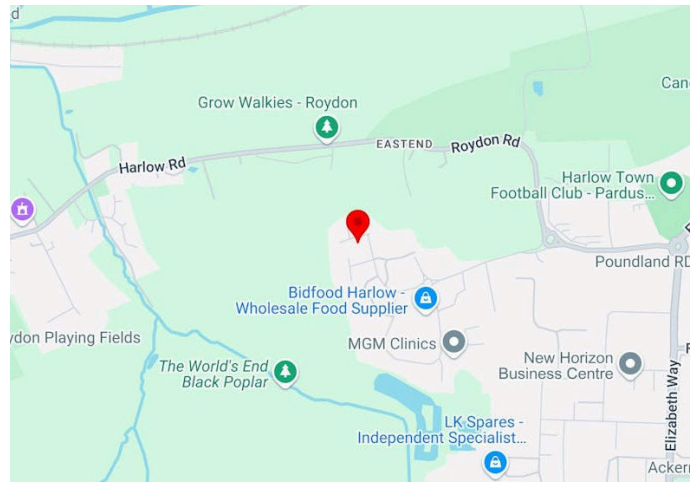

Description

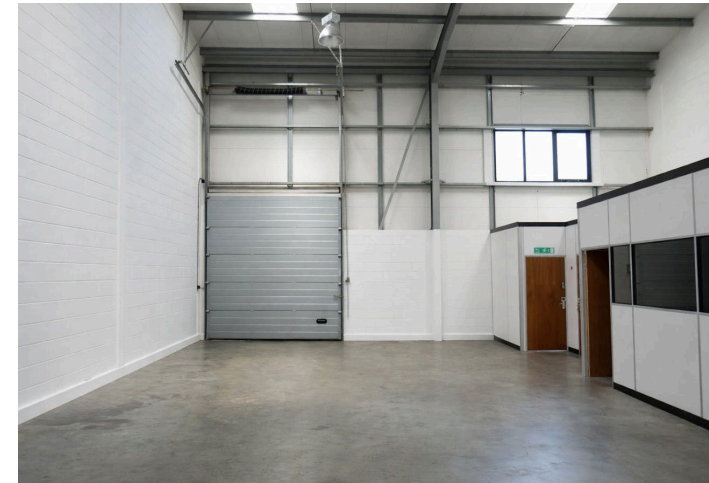
The property comprises a modern mid-terrace unit of steel frame construction with part brick infill and profile sheet cladding to the elevations, under an insulated pitched roof with translucent roof lights. The accommodation is all ground floor with reception, WC and office located to the left hand side. The rest of the space is clear span storage/production space.

Externally there is a brick paved forecourt for loading and unloading, and car parking.

Location

Harlow is a significant commercial centre in West Essex, enjoying good road links via J7 of the M11 to J27 of the M25 London orbital motorway some 6 miles South, and to Stansted approximately 13 miles to the North. The town also benefits from two railway stations, each serving London's Liverpool Street via Tottenham Hale (Victoria Line).

The property is located within a gated estate on Harlow Business Park which provides an attractive landscaped environment for both industrial/warehouse and office occupiers.
