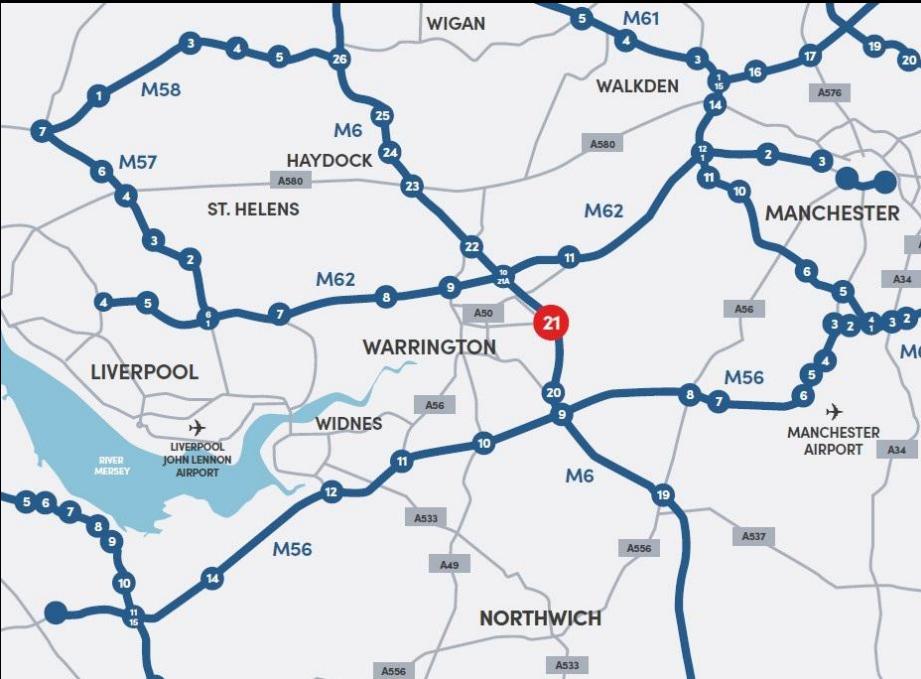
## DESCRIPTION
