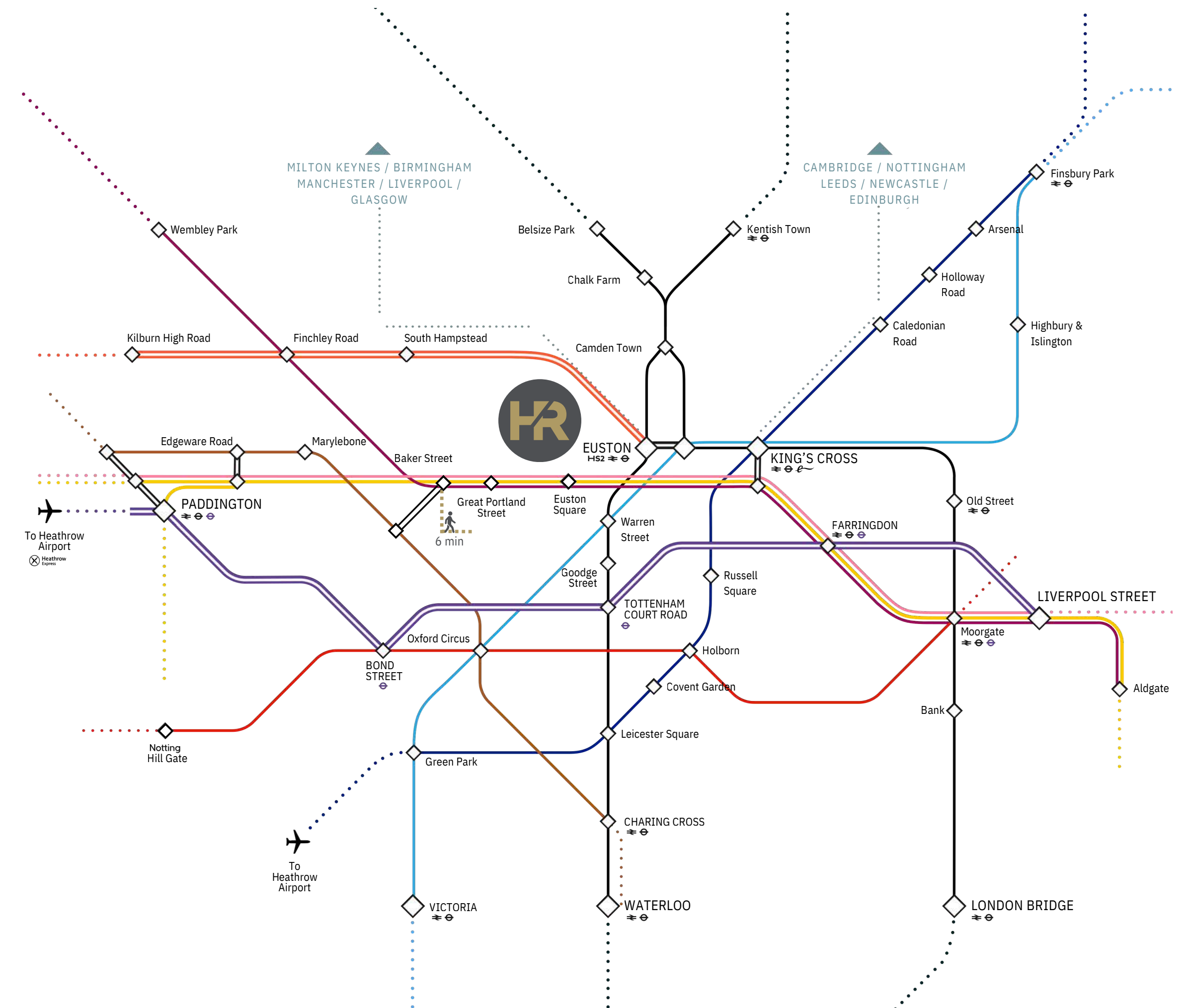

106 Hampstead Road comprises a freehold mixed-use building providing commercial accommodation at ground and lower ground floor level, with residential accommodation above.

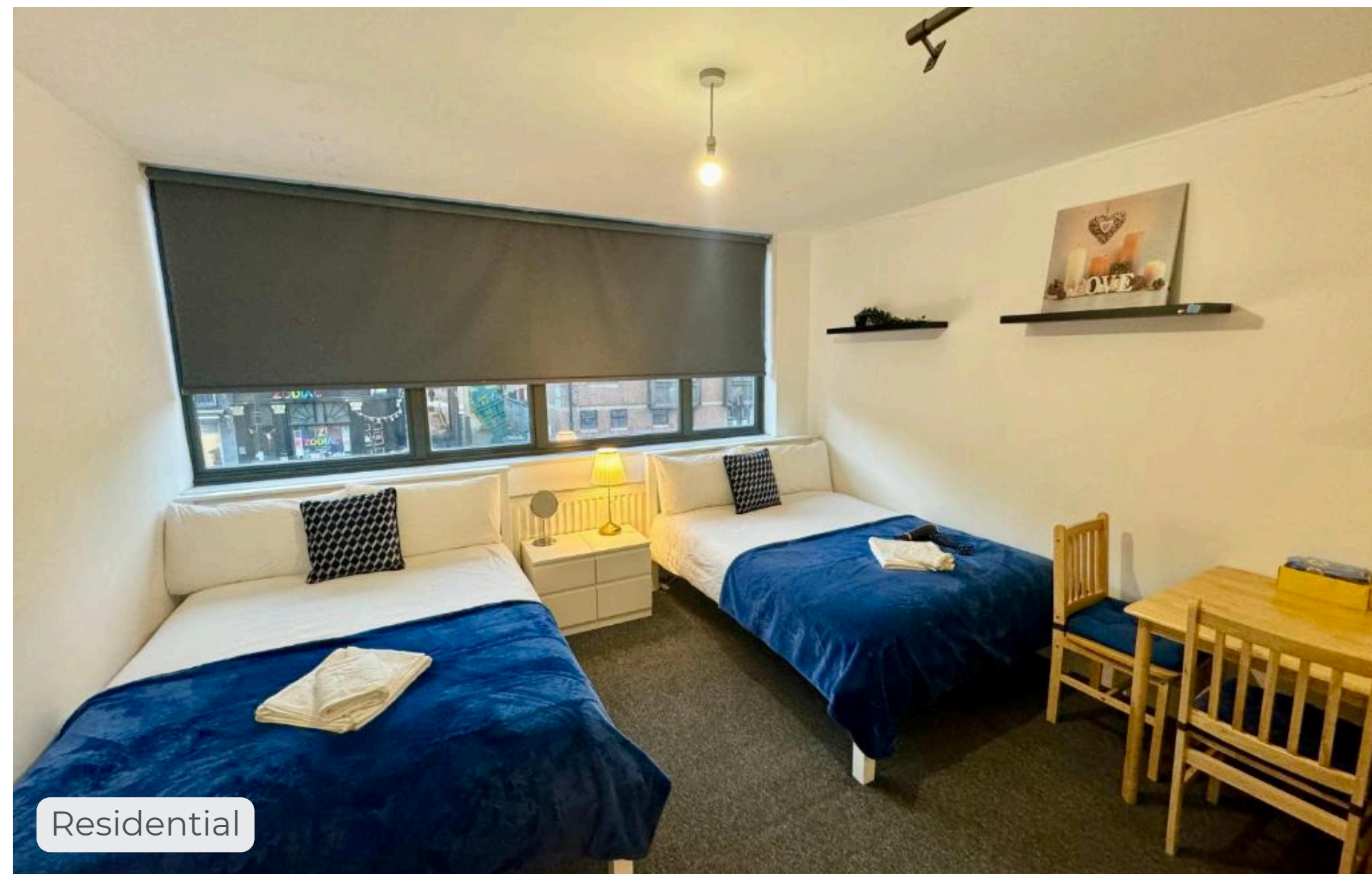
The commercial element extends 1,259 sq ft (NIA) of self-contained ground & lower ground accommodation.

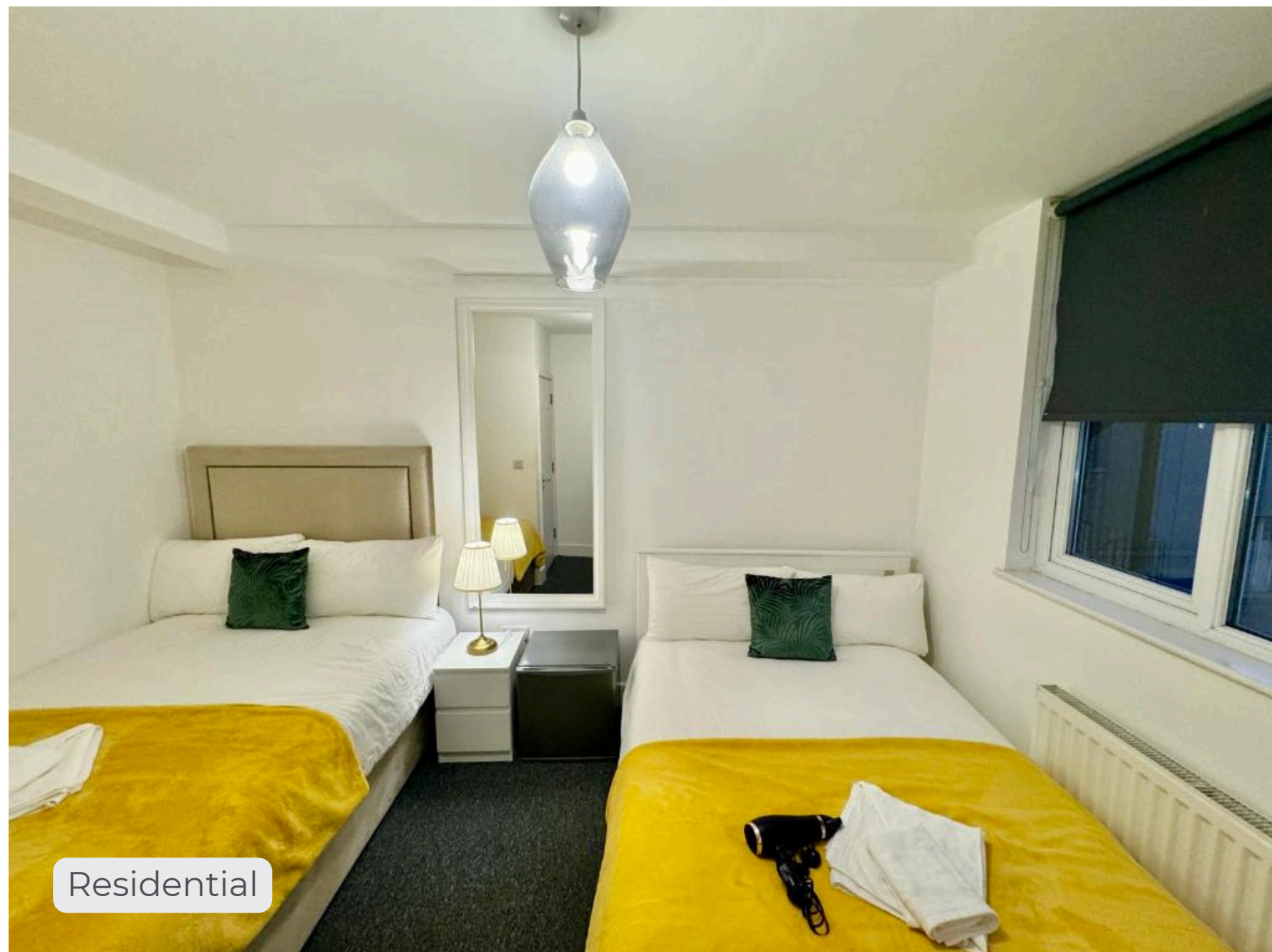

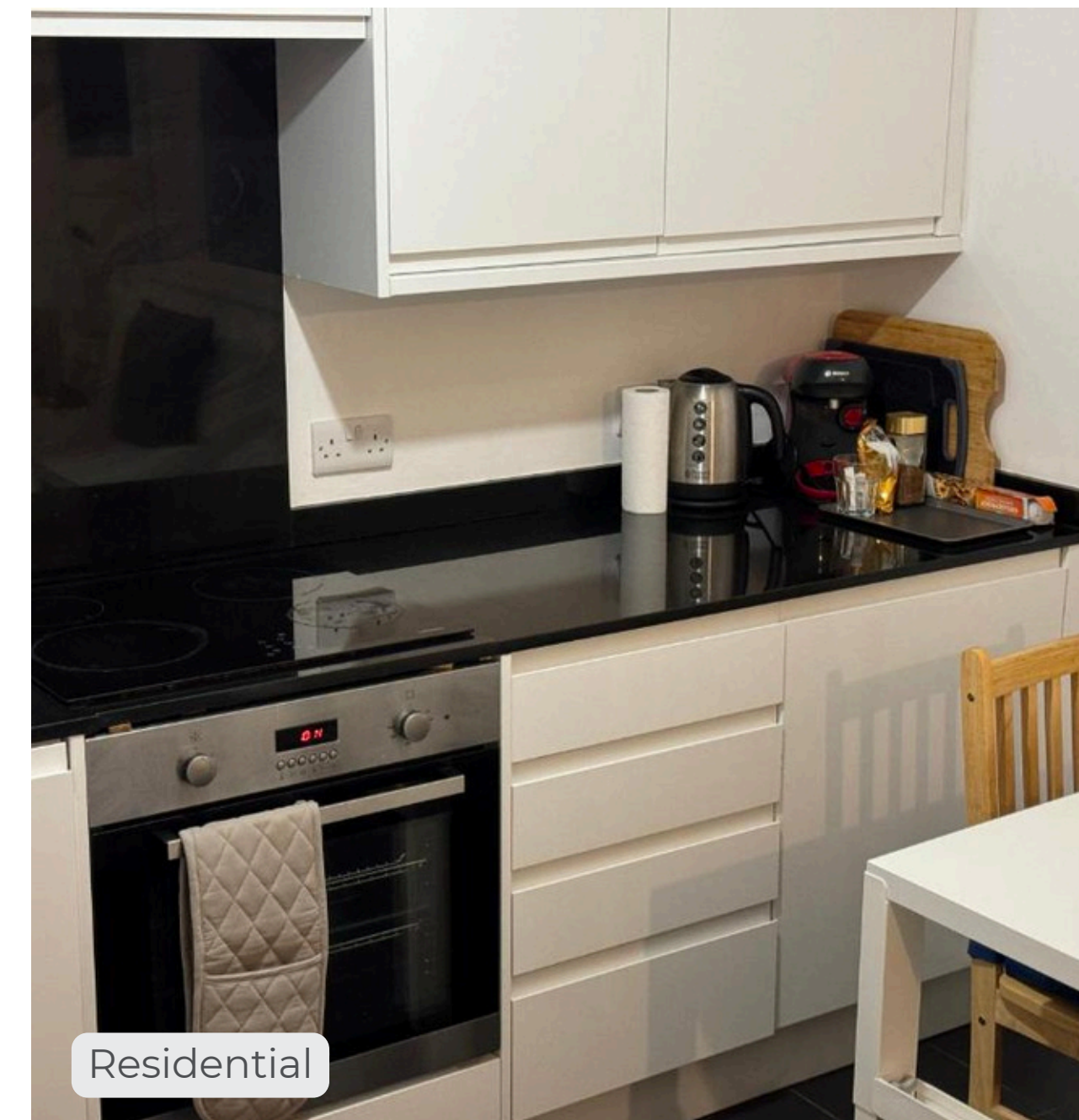

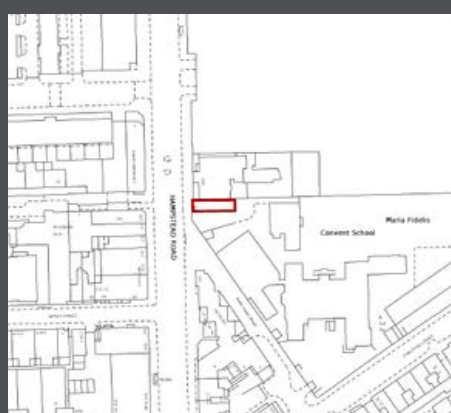
