

The site benefits from full planning permission for the reinstatement of a spacious 189,815 sq ft warehouse, strategically set back from the main road behind a cluster of modern industrial units, ensuring both accessibility and privacy. The design positions the building near the eastern boundary of the estate, making excellent use of the site's layout.

Previously home to a large warehouse destroyed by fire in 2023, the plot now presents a clean slate for redevelopment, with only the existing concrete slab remaining. The surrounding streetscape is defined by thriving industrial businesses, complemented by nearby car showrooms to the southwest. The land's gentle slope from east to west enhances drainage and development potential.

This is an outstanding chance to create a high-quality industrial facility in one of the region's most established and connected business hubs.
