# **Description**

The property provides a mid-19<sup>th</sup> century Grade II Listed building that reflects the historic architecture of the area and is within the conservation area. Internally the property provides a spacious retail sales area with kitchen and WC facilities to the rear elevation. Despite the unit having a large percentage of hard frontage, the unit offers good levels of natural light internally and would be suitable for a variety of uses, subject to obtaining the necessary planning permissions. There is on street parking provision directly opposite the unit which is a pay a display along with numerous multi-storey car parks situated only a short distance away.

Occupiers in the immediate and nearby vicinity include The Bridge Tavern, Akenside, Aveika, Babbucho, Slug & Lettuce, House of Tides and The Dubliner amongst numerous other national and regional operators.


#### Location

Newcastle upon Tyne is located in the North East of England and has an urban area population of some 190,000 persons. Newcastle is principally accessed via the A1, A19 and A69. Newcastle Airport, 7 miles north west of the City Centre, provides international and domestic services. Sunderland is located 14 miles to the South East, South Shields 14 miles to the east and Carlisle 58 miles to the west.

14 Akenside Hill is located in the heart of Newcastle upon Tyne, near the iconic Quayside area. Akenside Hill is a small, sloped street that connects the Quayside with the city centre. The area is known for it's historic architecture with a mix of Georgian and Victorian buildings. The street is relatively narrow and cobbled, creating a traditional feel throughout. From Akenside Hill, you have easy access to the River Tyne and it's famous bridges which includes the Tyne Bridge, Swing Bridge and Millennium Bridge. The area is bustling with a variety of bars, restaurants and cafes making it a popular spot for both locals and tourists.

## **Service Charge & Insurance**

#### **Business Rates**

With effect from 1 April 2023 we understand the property is assessed for rating purposes as follows:

The Rateable Value falls under the current threshold of £12K meaning that majority of operators could qualify for Small Business Rates Relief. 
