LOCATION

The subject property is located on Queensberry Avenue just off Queen Elizabeth Avenue in the Hillington Park area of Glasgow. Hillington Park is located at Junction 26 of the M8 motorway between Glasgow City Centre to the east and the towns of Paisley and Renfrew to the west.

Hillington Park is one of Scotland's largest industrial and business parks providing over 2M sq ft of commercial property for a diverse range of businesses. The Park benefits from two train stations and is two minutes from the motorway and two miles from Glasgow Airport.
