DESCRIPTION

The premises are currently fitted out to a high standard for beauty/clinical use, offering a plug-and-play opportunity for similar occupiers. Alternatively, the unit can be stripped back to shell condition, providing a blank canvas capable of accommodating a variety of uses (subject to the necessary consents).

A key architectural feature, currently concealed within the existing configuration, is a high-pitched rear skylight at ground floor level, offering the potential to introduce excellent levels of natural light. This is complemented by generous floor-to-ceiling heights of approximately 3m, creating a bright, open and highly usable trading environment.

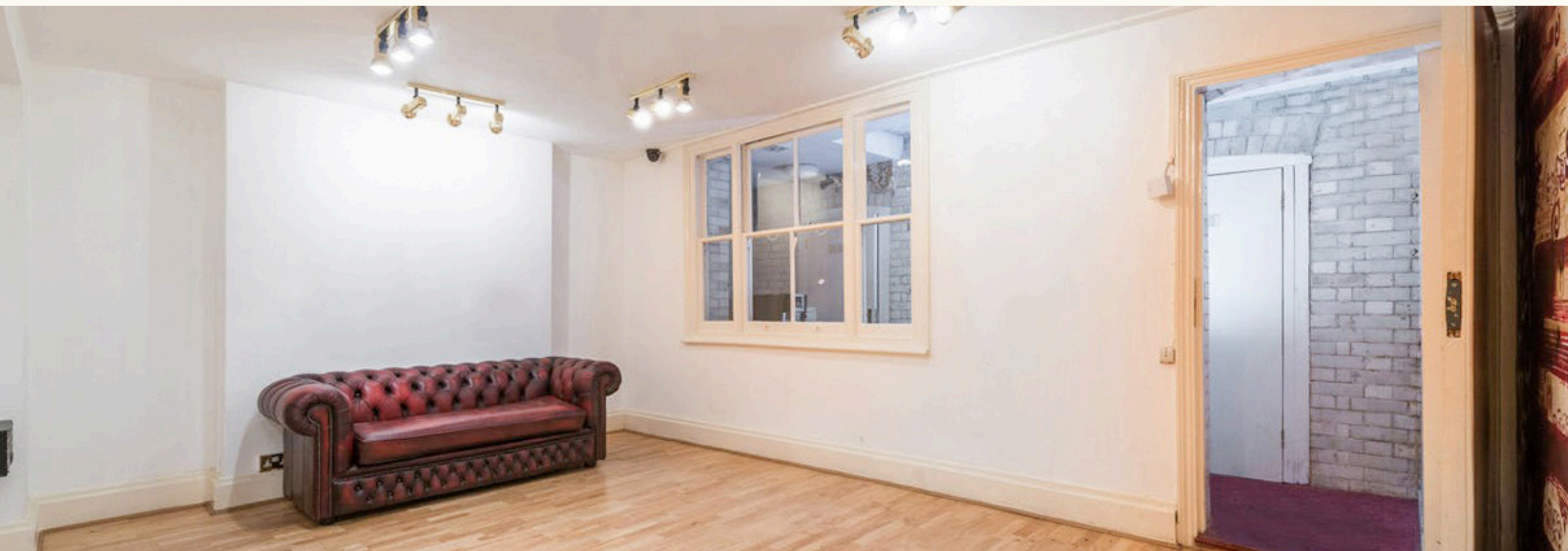
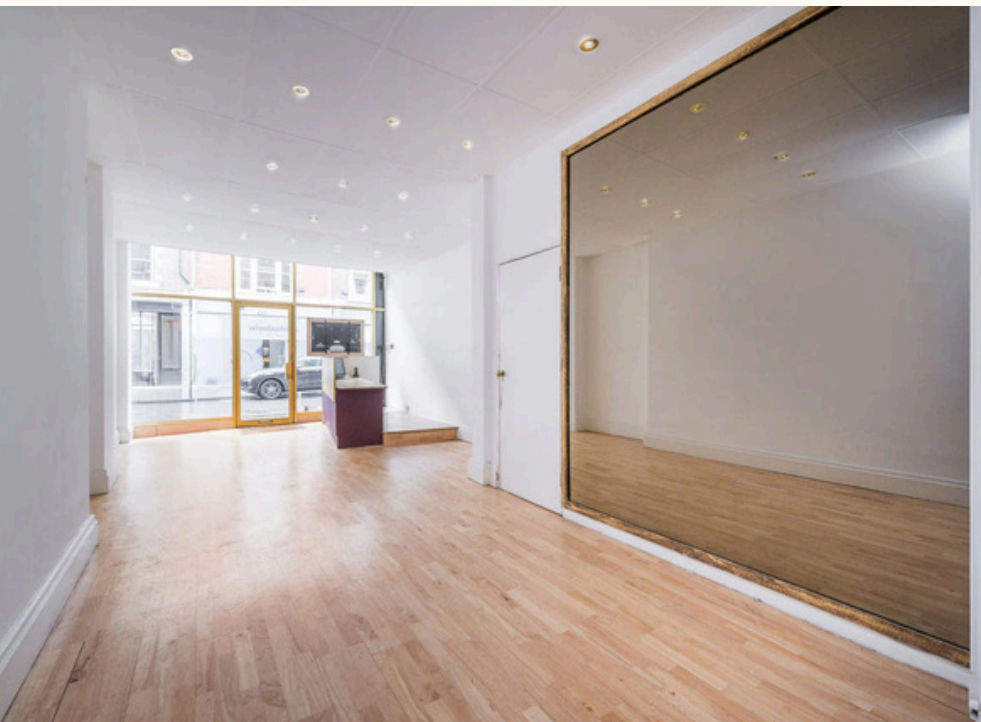

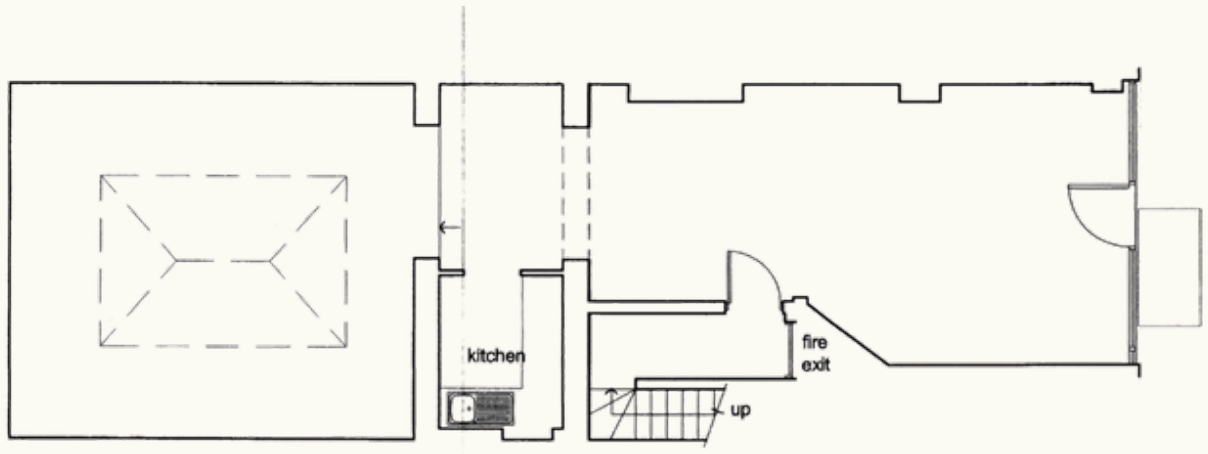

Former Photos - Open Plan Layout

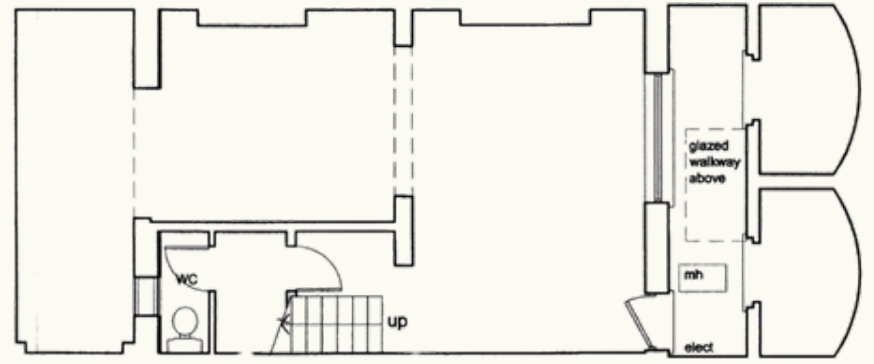

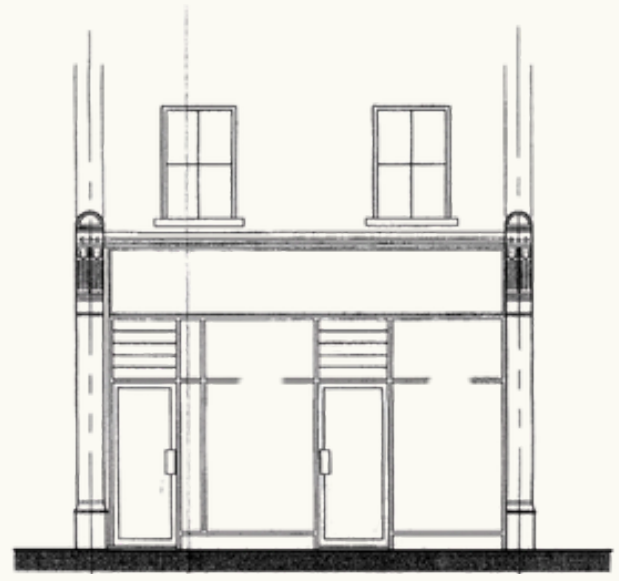
