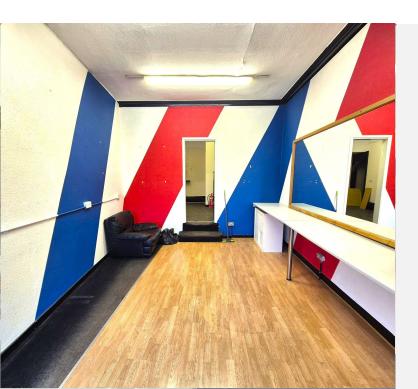

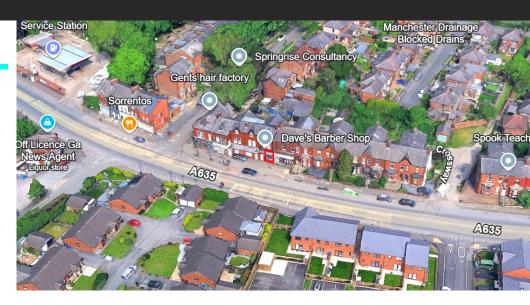
## Location

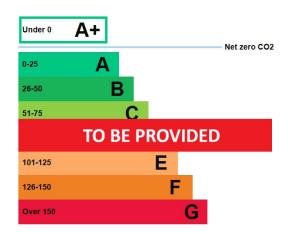
