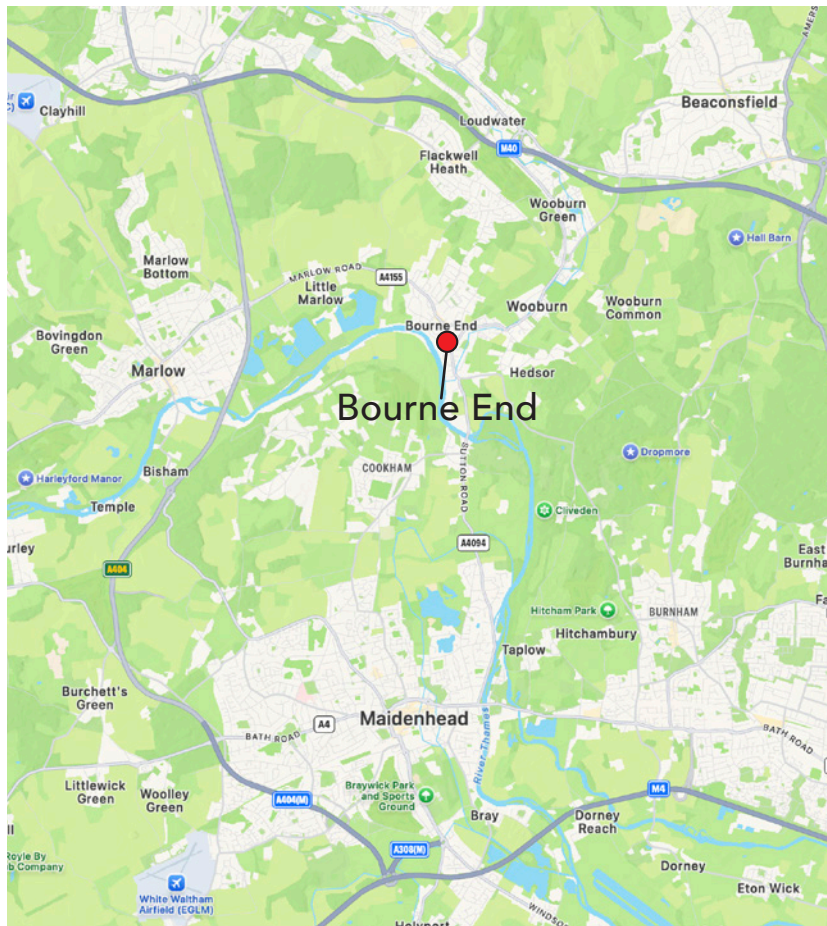
- Bourne End is an affluent market town in Buckinghamshire benefiting from good communication links to London

## LOCATION

Bourne End is an affluent market town on the River Thames, lying between the M4 and the M40 motorways. It is in a central location surrounded by several other towns including Marlow, Maidenhead, Beaconsfield & High Wycombe.

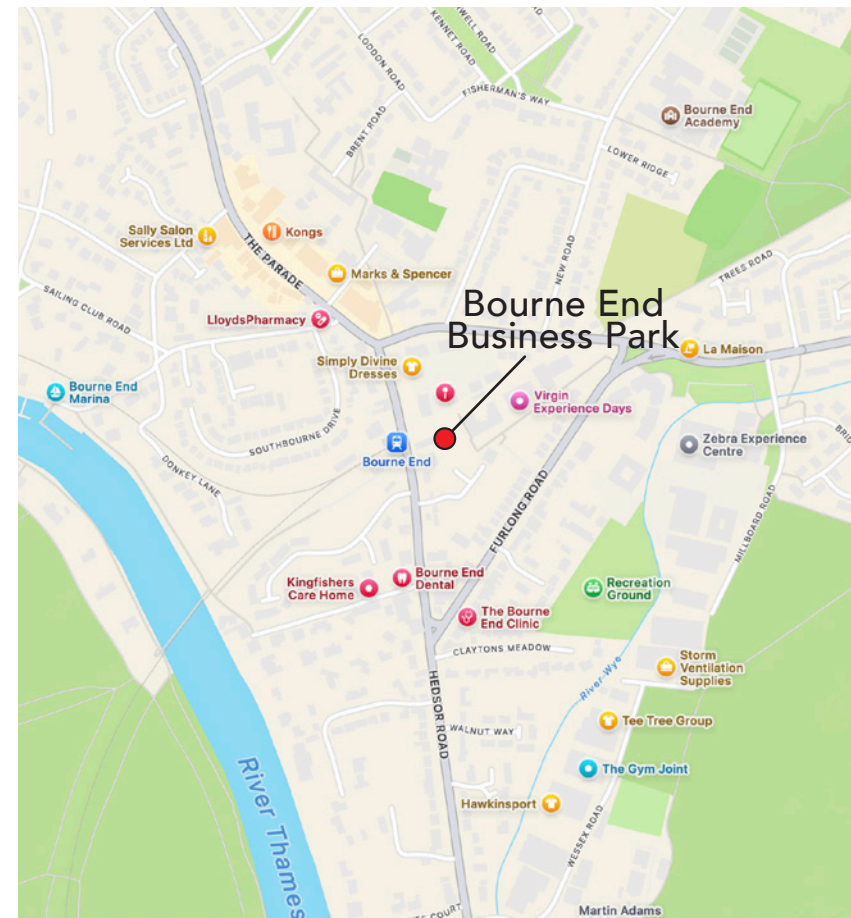
The town is at the southern boundary of the county of Buckinghamshire close to it's border with Berkshire. Maidenhead is 5 miles south and High Wycombe 6.3 miles north.



## SITUATION

The properties are situated on the Bourne End Business Park on the south side of Cores End Road ( A4155). The park is situated in the town centre opposite Bourne End train station and less than 100m from the High Street. This central location has ensured that there is good occupier demand whenever space has become available.

In total there are fifteen buildings on the park, two large offices including Cavendish House and then thirteen smaller units in five terraces which include units E and K.





## DESCRIPTION

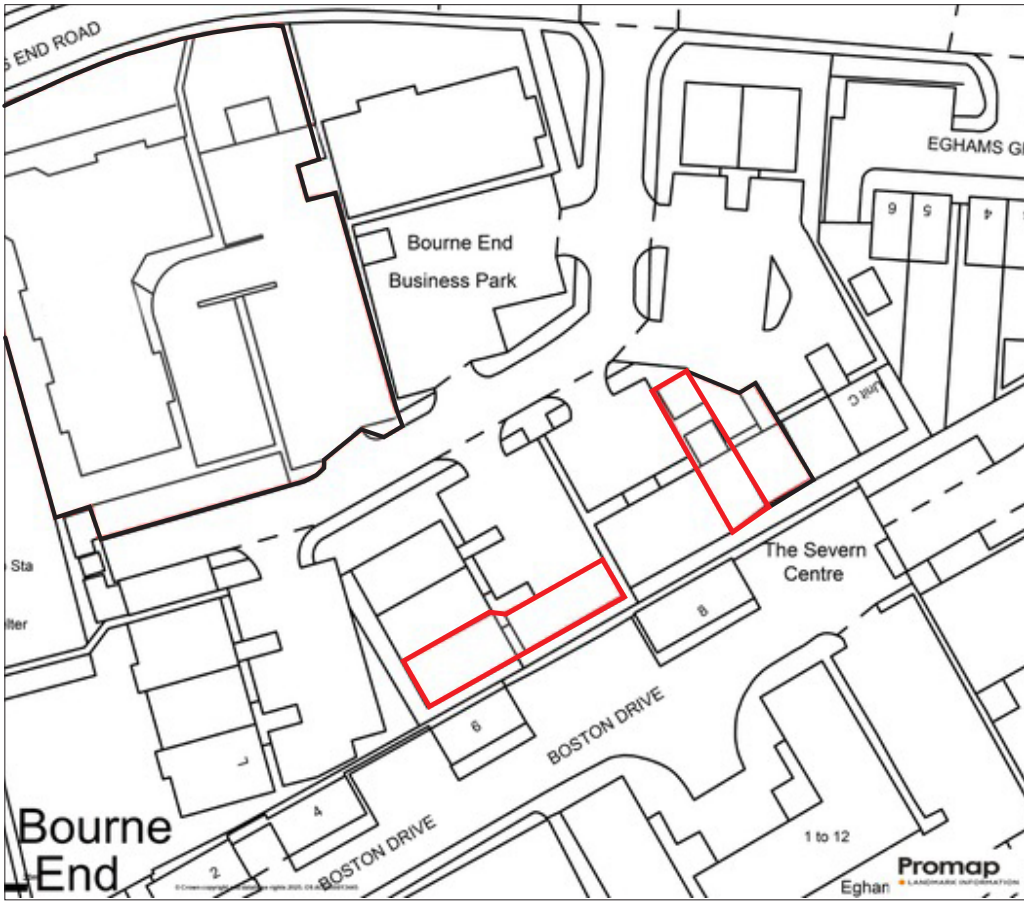
The investment comprises two single let self contained office units. Both buildings are two storey with brick elevations under a pitched slate tiled roof.

Units E and K are similar in specification in that they are end of terrace self contained offices with suspended ceiling incorporating Cat II lighting, fully accessed raised floor with toilets on ground and first floor.

## TENANCY

The two buildings are let in accordance with the schedule below. Both leases are full repairing and insuring.

An estate service charge is levied to all occupiers on the park which again is fully recoverable from the tenants.
