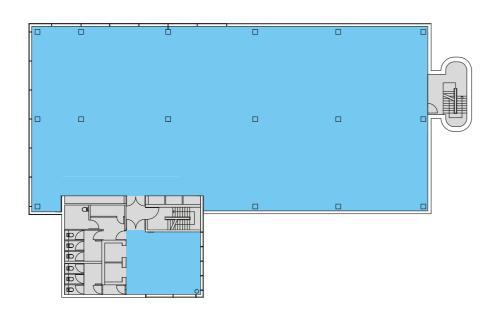






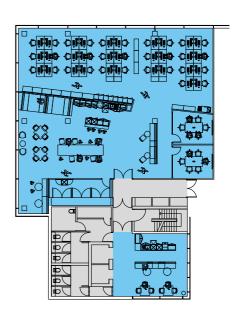
First Floor – Floor Plan

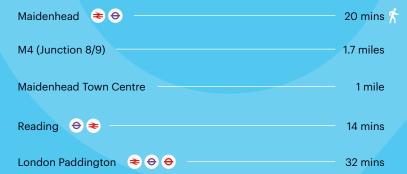
