## LOCATION

Basingstoke is a major centre for commerce and industry with a borough population of approximately 185,000. The Town is 45 miles to the south west of London adjacent to Junctions 6 & 7 of the M3 Motorway. There is also a frequent rail service to London Waterloo, with a fastest timetabled service of 45 minutes.

The Lister Road Industrial Estate is an established trade counter location where neighbouring occupiers include Rexel, Wolseley, Edmundson Electrical and Europcar.

## DESCRIPTION

**UNITS 17 & 18** comprise steel portal frame construction with lower brick and upper clad elevations, all under a pitched roof incorporating translucent light panels. The properties offer open plan full height space, with toilet and kitchenette facilities. In addition to the main loading door, there is pedestrian access to each unit from the shared yard area.

Unit 17 is a mid-terrace unit, with Unit 18 being at the end of the 3-unit terrace.
