Description

The Grade II Listed property currently comprises two distinct parts. The principal building comprises a Georgian 3 storey property with slate roof, whilst the secondary element is a later two storey extension, part flat roof, part pitched slate roof.

The building is approached from Deansway, via a delightful walled garden.

The property is currently utilised as offices, but will be vacated upon completion of a sale. The business which currently occupies the property is relocating into additional accommodation in central Worcester.

Planning permission has been granted by Worcester City Council for the conversion of the building into 9 apartments.

Location

The building occupies a prominent position on Deansway, just off the High Street, in the shadows of Worcester Cathedral. Whilst in the heart of the city, a short stroll takes you to the banks of the River Severn and Worcester Racecourse.

Worcester is a vibrant combination of past and present with a population of just over 100,000 perched on the banks of the River Severn.

The city boasts an eclectic mix of restaurants and bars together with an excellent retail offering, combining high street brands with a diverse range of independent boutiques.

It has a thriving and expanding University and offers sports enthusiasts first class cricket and rugby, together with a picturesque riverside racecourse.

Junctions 6 and 7 of the M5 motorway provide easy access to the motorway network and Birmingham airport, whilst the city has 2 mainline railway stations, Foregate Street and Shrub Hill in addition to Worcestershire Parkway which provides access to Regional and National destinations.
