

## Location


The site is strategically located between the recently completed Poynton Relief Road (PRR) and Adlington Business Park, within the Cheshire East borough.

The surrounding area is of mixed-use comprising industrial / employment along with agricultural land and leisure facilities.

Local occupiers of note on Adlington Business Park include Proseal, Cardiac Services, Senior Aerospace, and William Kirk, to name a few.

The completion of the PRR has significantly improved the site's connectivity. The PRR links directly to the A6 and connects with the Manchester Airport Relief Road approximately one mile to the northwest. This provides improved access to the wider Greater Manchester and National Motorway Network, including the M56 and M60 motorways. As a result, the site benefits from excellent regional and national transport links, making it highly accessible for logistics, business, and employment uses.





## Description

An employment development site situated adjacent to Adlington Business Park, Poynton.

The site was formerly Part of Adlington Golf Centre and is largely level and broadly triangular in shape.

There are ponds positioned to the north-east and south-east of the site. Retained rights will be required by the Vendor for drainage and maintenance.

It is proposed that the site will benefit from direct access onto the recently constructed Poynton Relief Road (PRR). The plan overleaf shows the notional accessway into the site, produced as part of a Stage 1 Road Safety Audit (RSA) prepared by Jacobs. Further information available in the data room.

## Planning

The site is allocated for employment use under Local Plan Site LPS 51 (Adlington Business Park Extension, Poynton), and as such, benefits from a formal employment allocation.
