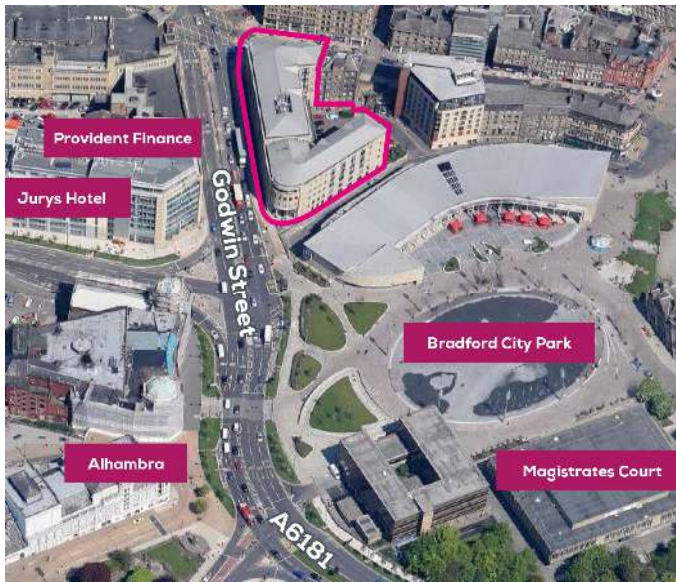


Location

Aldermanbury House is located in the heart of Bradford City Centre, having a commanding position overlooking Centenary Square and Bradford City Park. Fronting Godwin Street (A6181), the building is very accessible by car, with Bradford Interchange and Bradford Forster Square railway station also within easy walking distance.

Numerous nearby amenities include the Westfield Shopping Centre, the iconic Alhambra Theatre and the National Media museum. A Jurys Hotel is located opposite.

Major occupiers in the immediate area include Provident Financial, Bradford Council and Anchor Hanover who are based in the building.



Description

The ground floor offices are accessed from a fully refurbished contemporary reception, positioned on the corner of Godwin Street and Sunbridge Road.

The offices comprise some 13,742 ft² on a single floor, providing highly flexible and efficient floor space. The well appointed office suite has excellent natural daylight and provides for the following specification:-
