The property

Location & Situation

Rowley Regis, located at the heart of the West Midlands, is a well-established industrial location offering excellent connectivity and access to key regional and national markets. The estate lies within the Metropolitan Borough of Sandwell, approximately 8 miles west of Birmingham city centre and 6 miles east of Dudley, positioning it strategically within the UK's manufacturing and logistics corridor.

The estate benefits from strong transport infrastructure:

Road Access: Easy access to the A4123 and close proximity to the M5 motorway (Junction 2 is approximately 1.2 miles) provides direct links to the national motorway network, including the M6, M42, and M40, enabling efficient distribution across the UK. Access to Birmingham city centre is provided via the nearby A456, whilst access to Wolverhampton and Dudley is via the nearby A4123 Wolverhampton Road.

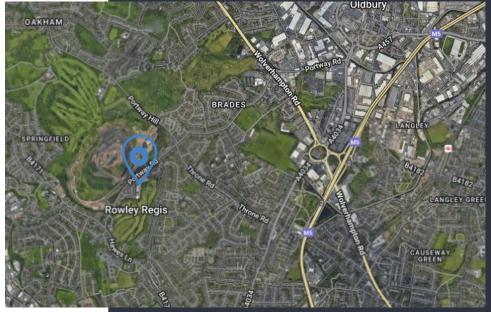
Rail Connectivity: Rowley Regis Railway Station, located just over a mile from the estate, offers frequent services to Birmingham Snow Hill and other key destinations via the West Midlands rail network.

Air Travel: Birmingham Airport is approximately 20 miles away, providing international and domestic flights, ideal for businesses with national and global operations.

Rowley Regis sits within the Black Country region, traditionally known for its strong industrial base and skilled labour force. The surrounding area benefits from a large population catchment, with over 2.8 million people living within a 45-minute drive time. Sandwell and the West Midlands Combined Authority continue to invest in skills and employment initiatives, making the area attractive for a range of industrial and logistics occupiers.

Droicon Trading Estate is situated on Portway Road approximately one mile north of Blackheath town centre. The immediate surrounding uses are commercial, modern residential and leisure in the form of Rowley Regis Golf Course.





Description

Units 1–12 on the estate are of similar construction, forming a cohesive and functional row of industrial units designed for a range of commercial uses.

Specifically, Units 1–12 are of similar concrete frame construction beneath sheet roofs, with part brick and profile clad elevations that provide both durability and a professional appearance.

Each unit is accessed via a roller shutter door, secured by two ram poles. These units benefit from generous eaves heights of approximately 5.12 metres, allowing for efficient vertical storage or operational flexibility.

Several units feature mezzanine floors, WC facilities, and kitchenettes, offering added convenience for occupiers. Most industrial units on the estate additionally benefit from office facilities.

Opposite this main block, Unit 14 stands independently and is of traditional brick construction with a steel truss roof and includes an adjoining brick-built ancillary office with WC accommodation, with access available either through the office entrance or directly via a roller shutter door into the warehouse.







Accommodation and Tenancy

The accommodation is let on effective FR&I leases and licences in accordance with the schedule below. An estate service charge is recovered from the tenants to cover insurance, maintenance and repair of the common parts amounting to £0.31 psf
