Location

The property is located in the centre of Romsey and fronts onto The Hundred which is Romsey's main shopping and business centre. The property is in the centre of Romsey and this part of The Hundred is prime retailing area of the town. Occupiers represented in the town include **WAITROSE, COSTA, WATERSTONES, FAT FACE, CAFFÉ NERO** and **THE SMITH BRADBEER DEPARTMENT STORE**.

Romsey in an attractive market town, approximately 8 miles from Southampton, 11 miles from Winchester and 16 miles from Salisbury. There is good access to the main road networks with connections to the M27 and M3. The property is within a short walking distance of the main line railway station with links to Southampton and further national destinations.

The property comprises a period building, consisting of the main building fronting The Hundred, which is constructed on ground, first and second floors.
