## Description

The subject property offers a contemporary business unit benefitting from a double glazed aluminium framed shop frontage facing directly onto Forth Street, internal electric roller shutter, strip lighting, hot water heater and WC facilities. The property is comprised over ground floor & mezzanine and sits within the parade of arches and opposite The Telegraph Pub, Student Accommodation, Genting Casino and Roomz Aparthotel which benefit from consistent passing trade / footfall daily. Central Square North & South offices are situated on Orchard Street housing a number of high-profile companies that have large workforces which increases trade significantly in this location. The unit has also recently been fully refurbished to an excellent standard.

## Asking Rent & Tenancy Agreement

£15,500 per annum exclusive of VAT with terms to be agreed, subject to contract.

## Location

The property is situated on Forth Street only a short 2 minute walk from Central Station which has been the subject of significant investment extending the external and public realm areas with a programme of pedestrianisation in order to create a sense of arrival and a true gateway to the city centre. There are a variety of commercial uses in close proximity including Grade A office accommodation, bars & restaurants and retail establishments. Nearby occupiers include The Boiler Shop, The Pattern Shop, Sleeperz Hotel, Tokyo Bar, Nandos, Manhattan amongst numerous other national and local operators.

## Service Charge

There is currently no service charge attached to this property, however, this may be subject to change.

## Use/Planning

The property has consent for Sui Generis under the Town & Country Planning Use Classes Order as amended 1 September 2020.

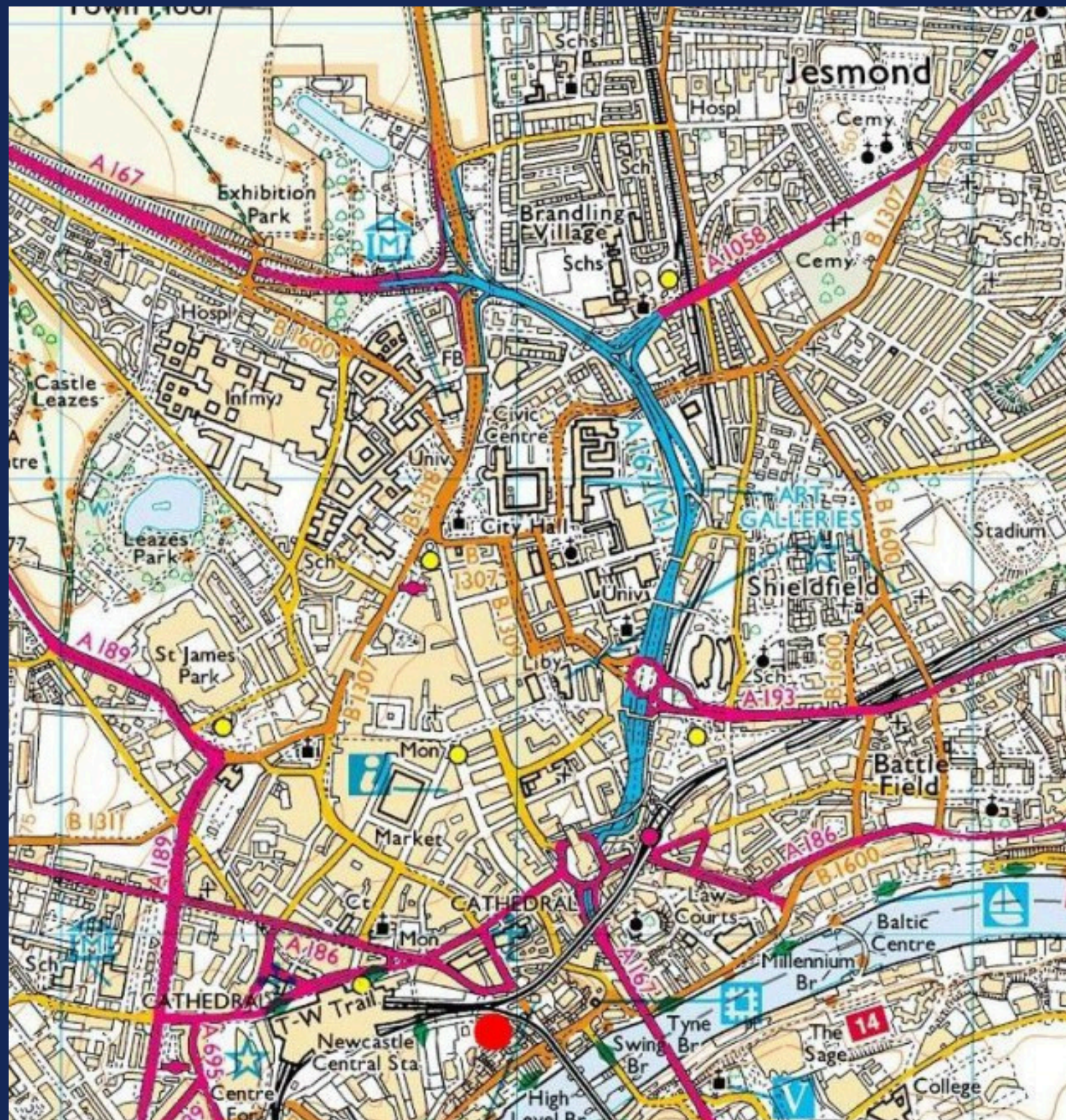
Alternative uses may be considered subject to obtaining the necessary planning consent from the Local Planning Authority, Newcastle City Council.

## Services

## Business Rates

With effect from 1 April 2023 we understand that the property is assessed for rating purposes as follows:
