Situated in a prominent position fronting Lancaster Road, the property benefits from excellent visibility within an established commercial area. With eight dedicated car parking spaces, it offers strong convenience for staff and visitors alike, making it an attractive choice for businesses looking to establish or expand their presence in a well-connected location.

# First Floor, Lancaster House

The property comprises part of a detached two-storey mixed-use building known as Lancaster House. The available accommodation is a self-contained first-floor office suite providing a Net Internal Area of approximately 2,605.78 sq ft (242 sq m), accessed via a dedicated ground-floor entrance.

The suite benefits from its own separate lockable and alarmed access, with CCTV in operation across the site, providing enhanced security for occupiers. The accommodation has been recently decorated and benefits from newly fitted carpets throughout.

Internally, the space is arranged to provide seven individual offices, welfare facilities and a fitted kitchen, with access via an attractive glazed atrium to the front elevation.

Externally, the property benefits from eight allocated car parking spaces situated to the front of the building.



## Location

The property occupies a prominent position on Lancaster Road within a well-established commercial and industrial area, approximately 2 miles north of Shrewsbury town centre and just 1 mile from the A5 Bypass. Nearby occupiers include Express Car Valeting Centre, M&B Motor Services and Royal Mail, contributing to a strong and active business environment.
