Through front door into **Restaurant** with wooden tables and chairs for 30 covers, feature low level ceiling lighting, shelving, wall mounted flat screen television, CCTV camera, wall mounted air conditioning unit, servery counter, shelving, 2 upright glass fronted chiller display cabinets, insectocutor. Door to Cloakroom. From Restaurant through door into Lobby with non slip floor. Through into **Ladies Cloakroom** with low level WC, pedestal wash hand basin, paper towel dispenser, fully tiled, extractor fan. **Gents Cloakroom** with low level WC, pedestal wash hand basin, paper towel dispenser, fully tiled, extractor fan. Door from Restaurant through into **Kitchen** with single drainer single bowl stainless steel sink unit, worktop surface, kettle, counter fridge. Through into **Main Kitchen** with non slip floor, 2 x 3 cupboard chiller counter units, mix of tiled walls and stainless steel wall coatings, double deep fat fryer, shelving, 6 burner gas range, 7 burner Chinese cooking range, extensive extraction system above, stainless steel table, microwave. Through into **Wash Up Area** with tiled floor, tiled walls, double deep bowl stainless steel sink unit, double chiller counter unit, upright freezer, upright fridge, blender, microwave, rice cooker, paper towel dispenser. Through door into **Store** with upright fridge freezer, upright freezer, 3 chest freezers, stainless steel table. Through into **Storage Shed** with shelving, stainless steel table. Through door to OUTSIDE Covered Courtyard with storage shelving, bin store area.

Trading & Business

The owners inform us that they currently operate 6 days a week, Monday to Sunday (closed on Tuesday's). The restaurant currently provides authentic Korean cuisine and enjoys a loyal following amidst both students and locals. It is known for its high quality food and friendly service. Accounts can be made available to genuinely interested purchasers.

Licences/Permissions

We are informed that the property holds a Premises Licence granted by BCP Council (Bournemouth). The Licensing Act 2003 states that properties serving alcohol have a designated premises supervisor who must hold a Personal Licence. Rateable Value
