
#### **LOCATION**

Clow Business Park is situated in Cradley Heath, a well established industrial and commercial location within the West Midlands. Cradley Heath forms part of the Metropolitan Borough of Sandwell and lies approximately 9 miles west of Birmingham city centre and 3 miles south of Dudley.

#### **SITUATION**

Clow Business Park occupies a convenient position on Garrett Lane, close to its junction with Corngreaves Road (A4100). The estate is well located for access to the regional road network:

- •M5 Motorway (Junction 2 or 3) approximately 5 miles to the east, providing direct links to the M6, M42 and national motorway network.
- •A458 and A4034 nearby arterial routes connecting to Dudley, Stourbridge, Halesowen and Birmingham.
- •Cradley Heath Railway Station within 1 mile, offering regular services to Birmingham Snow Hill and Worcester.
- •Birmingham city centre approximately 9 miles to the east.

#### **DESCRIPTION**

The estate comprises a substantial industrial warehouse that has been split to provide a number of industrial workshops and warehouses with a two-storey element to the front of the main building.

The two-storey element is of traditional construction with brick elevations beneath a flat felted roof.

The main warehouse areas vary in specification being constructed in part with streel portal and steel truss construction with all being surmounted by a pitched roof and full height brickwork elevations.

All units benefit from concrete flooring and roller shutter access to the main vard area.

The estate benefits from forecourt car parking in addition to a secure yard area with access around the estate.

Number 44a situated to the front of the estate, comprises a derelict two storey property.
