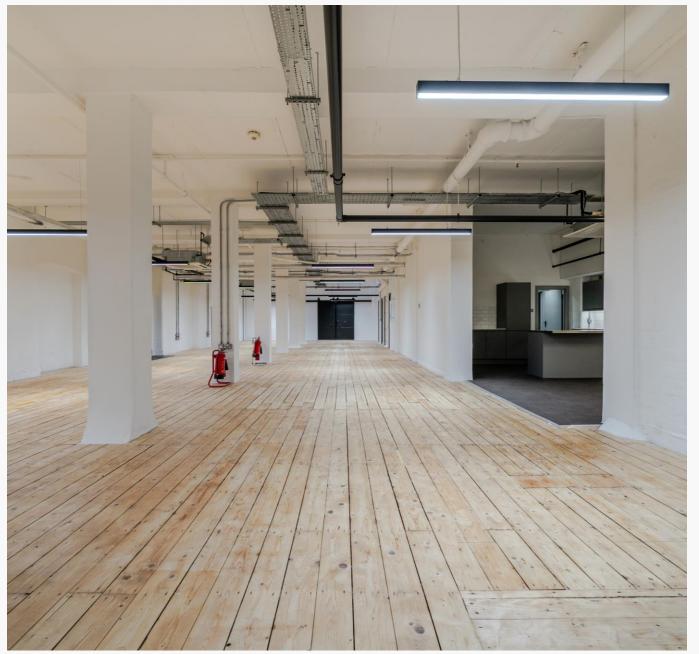

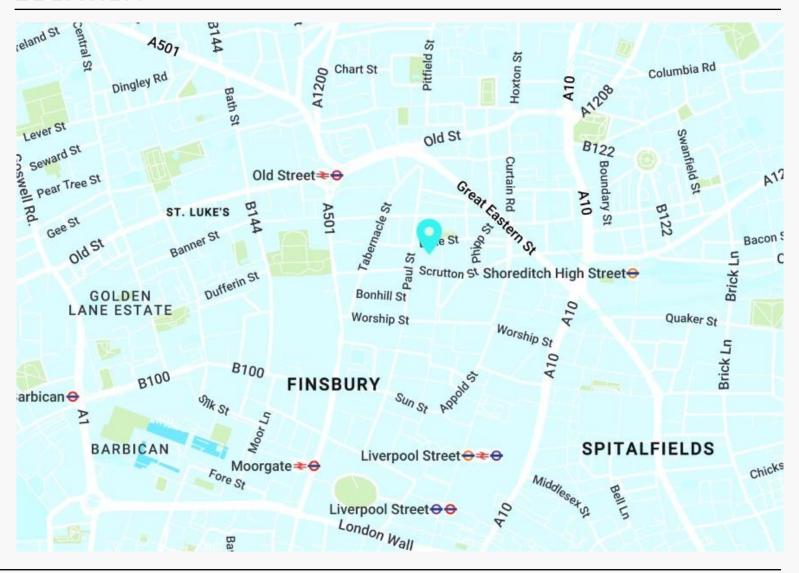
#### **AREA**
