Location

Unex House is located on Hills Road within the heart of the Cambridge central business district and benefits from local amenities such as the Cambridge Leisure Park which includes a number of restaurants, supermarkets and entertainment venues.

Unex House is located on Hills Road and is within close proximity to Station Road which is the home for numerous global tech companies including Microsoft, Apple and Amazon. Cambridge mainline train station is a 5 minute walk away from Unex House, which provides a train service to London Kings Cross (c. 48 minutes) and London Liverpool Street (c. 1 hour and 5 minutes).

The city of Cambridge is strategically located approximately 50 minutes north of London, which can be accessed from the M11. This motorway provides access to the wider UK motorway network and to the A14 and M6 respectively. The M11 provides direct access to Stansted Airport (25 miles) which can also be accessed by direct train from Cambridge train station.

Neighbouring occupiers include AstraZeneca, Secondmind, GEANT and Rathbones.
