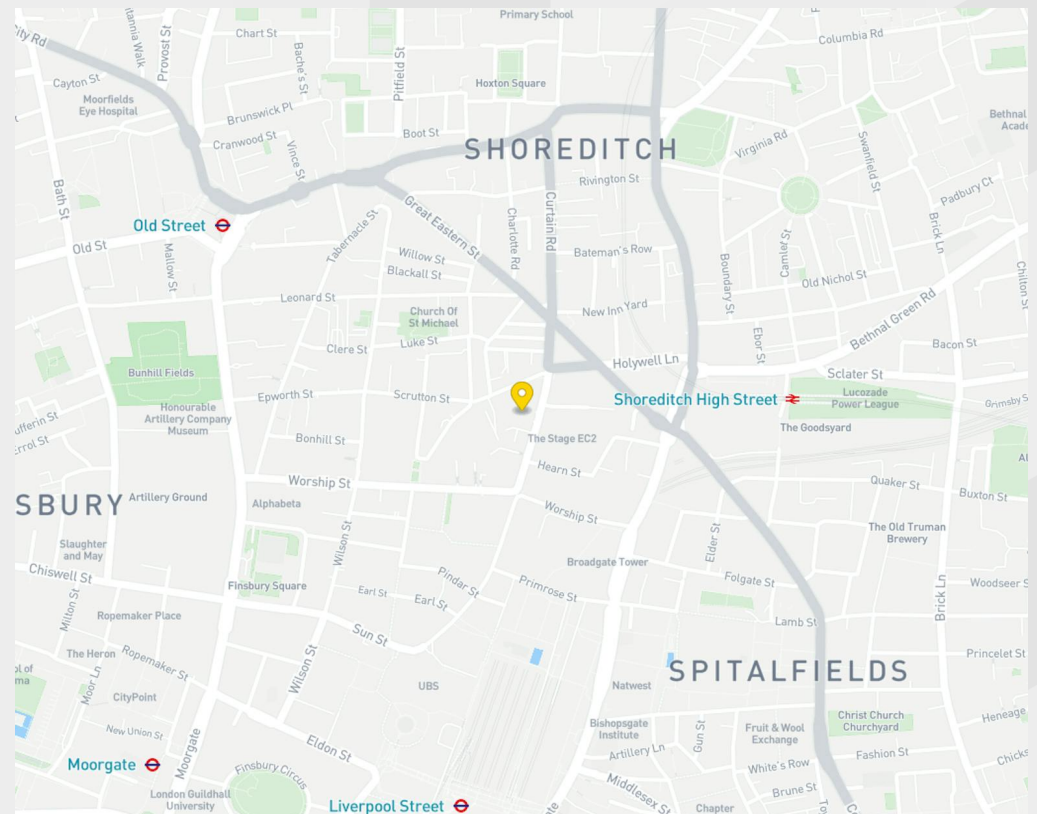
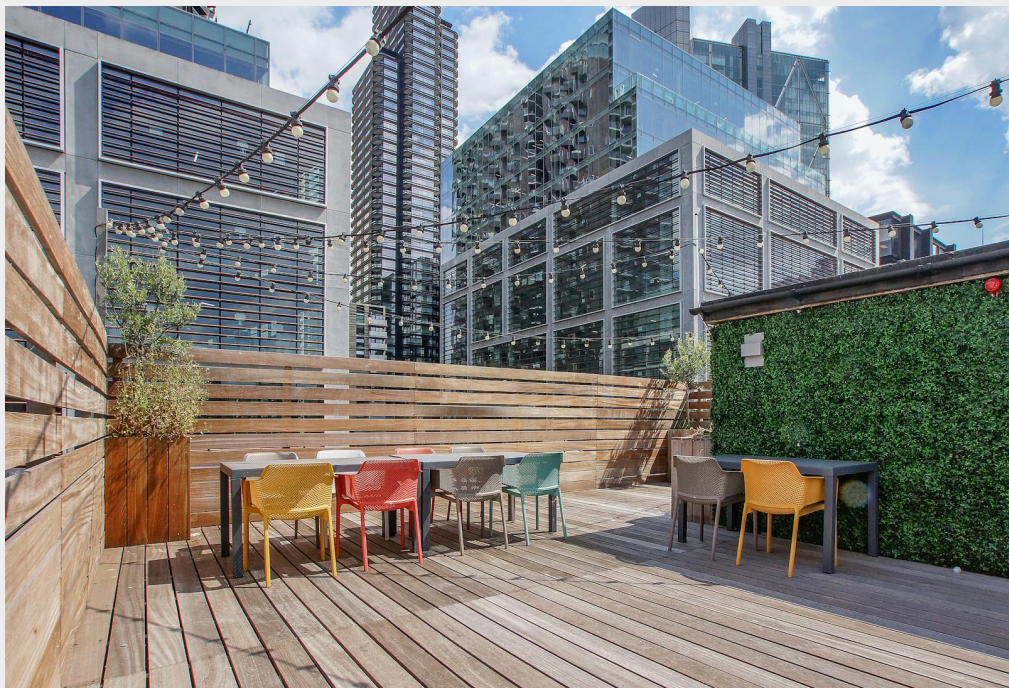


Description

The building is situated on the west side of Curtain Road and a short distance south of the junction with Great Eastern Street, in the heart of Shoreditch. Old Street (Northern and Mainline services) and Shoreditch High Street (Overground) stations are also accessible within a 7-minute walk.
