#### **Property Highlights**

16 & 17 Framlington Place comprises a large, Grade II listed, midterraced, four storey, brick-built office building in Newcastle Upon Tyne located directly adjacent to Newcastle University campus and within close walking distance to Northumbria University.

The property has a large garden space at the front of the property and parking to the rear of the property, currently providing space for 6 vehicles with the potential to accommodate up to 8 if required.

#### **Opportunity**

We are instructed to offer the freehold interest in the building with full vacant possession.

Framlington Place and surrounding area has a strong student presence, with parts of the Newcastle University campus being on the doorstep of the subject property and Northumbria University being approximately a 20-minute walk away.

This Grade II listed property presents an ideal opportunity for redevelopment subject to planning and Historic England consultation.

#### Tenure

The premises are available to purchase on a freehold basis with full vacant possession.

#### **Planning**

16 & 17 Framlington Place is a Grade II listed property. We advise interested parties make their own enquires regarding any change of use that may be required.

#### **EPC**

The property has an EPC assessment of E (104).

#### Location

The property is situated on Framlington Place. The area immediately surrounding the subject property is predominantly residential with some commercial uses. Newcastle city centre is 0.5 miles away and can be accessed on foot in just under 15 minutes.

Access to Framlington Place is via Claremont Road, directly off the A167 (M). The A167 provides routes both North and South and connects with the A696, which allows Newcastle Airport to be accessed in 10 minutes.

Newcastle has excellent public transport links. The metro service provides routes throughout Tyne and Wear. Newcastle also has a bus services which provides access to the wider north-east region

#### **Purchase Price**

### **Ground Floor**





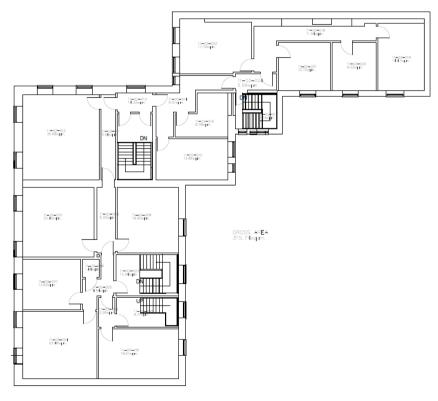


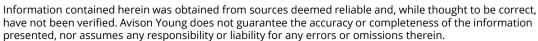

### **First Floor**



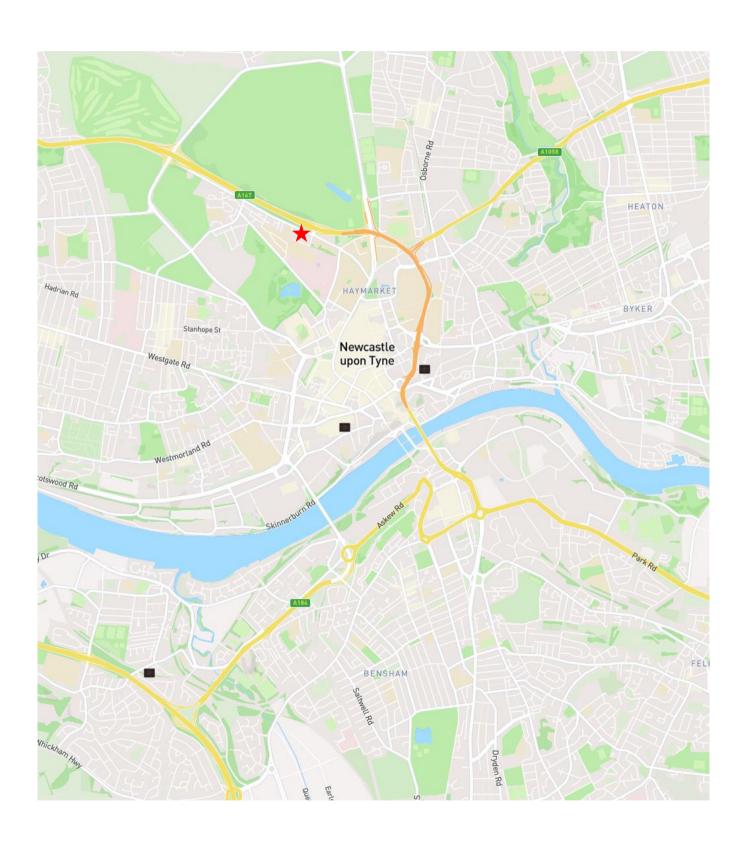

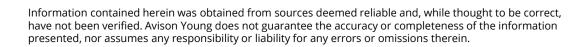
