DESCRIPTION

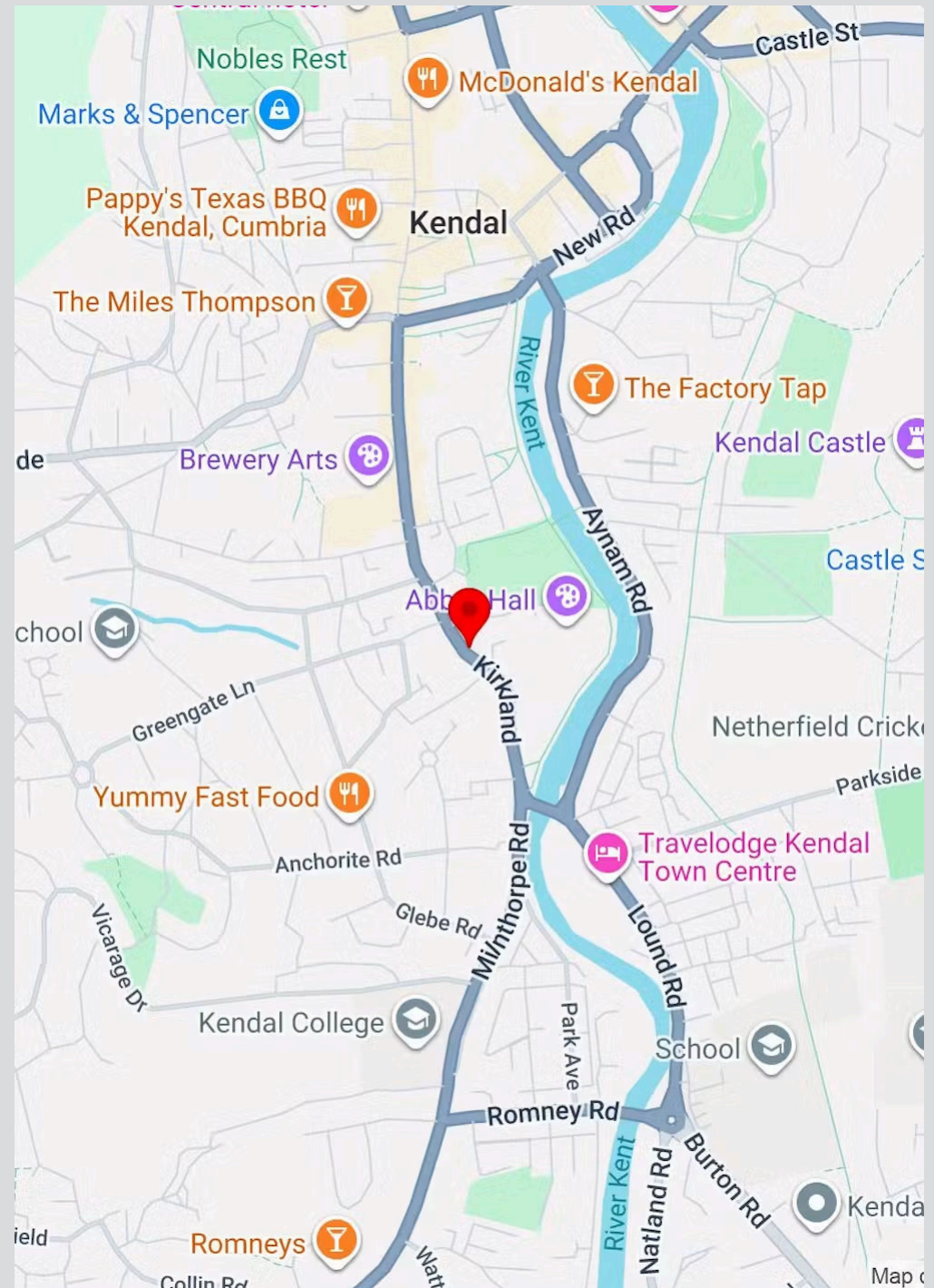
Situated towards the lower end of town on Kirkland, this charming property has most recently been used as a photography studio and office space.

Presented in excellent condition, the property has been sympathetically modernised while remaining in keeping with its historic character. Original features, including open fireplaces and exposed beams, have been carefully retained, complemented by modern additions such as an updated kitchen and contemporary shower room.

Accessed directly from Kirkland, the property opens into a spacious open plan area which leads through to the kitchen, a useful storage area, and shower room.

To the rear, there is access to a small communal courtyard, from which a basement can be reached, providing further ancillary storage space.

Although most recently used as studio space the property would lend itself to a range of commercial uses, including general office, retail and therapy space.



LOCATION

Located on Kirkland, the property occupies a position on the main arterial route into the town centre. It is situated within an attractive historic area, close to the Parish Church and surrounded by a variety of character properties.

The surrounding area is home to a mix of established occupiers, including the well known Pete Bland Sports, hair salons, independent retailers, and a range of professional office users.

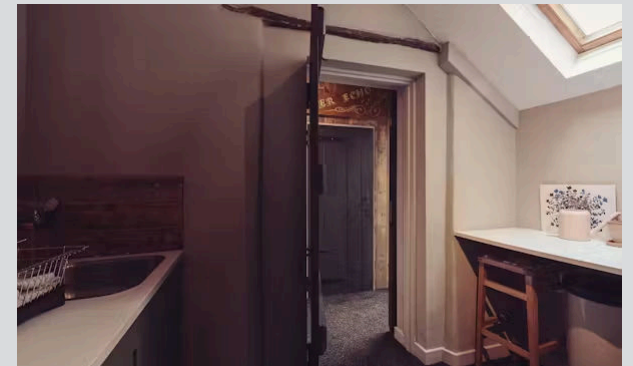
